



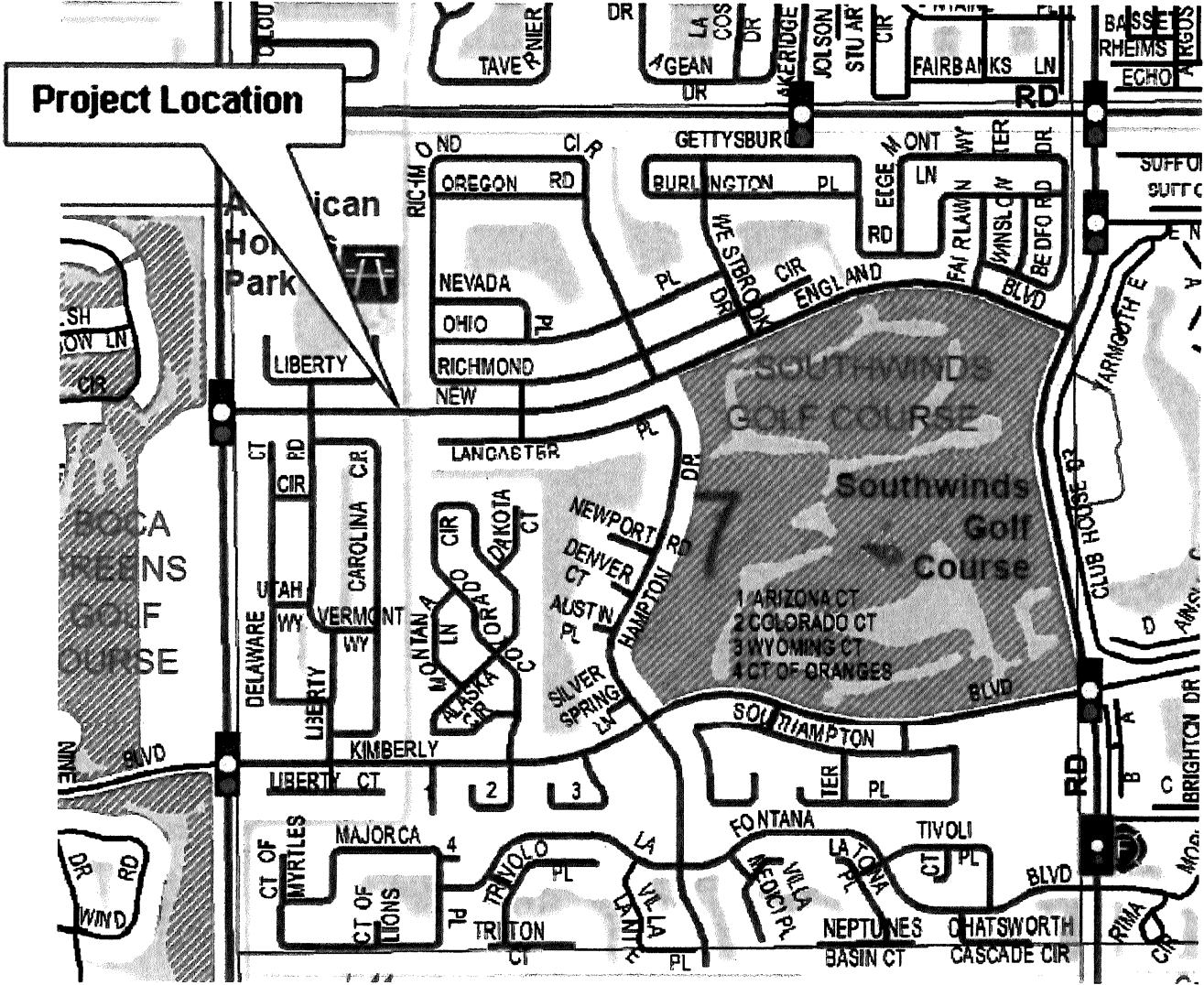






**NEW ENGLAND BLVD OVER E-1 CANAL BRIDGE**

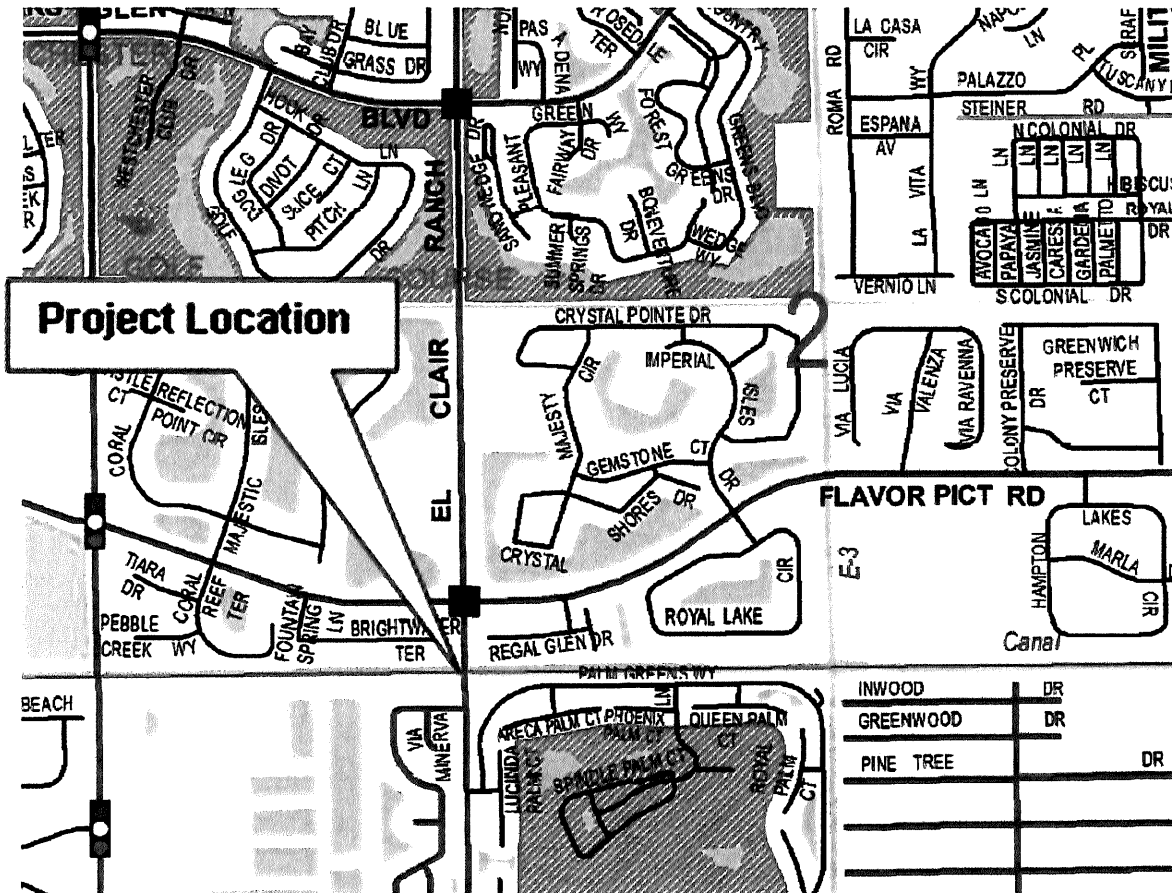

**RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS  
OF PALM BEACH COUNTY, FLORIDA, ENDORSING THE  
CLOSURES DURING CONSTRUCTION OF THE FOUR BRIDGE  
REPLACEMENT PROJECTS BY THE FLORIDA DEPARTMENT  
OF TRANSPORTATION.**

**WHEREAS**, the Florida Department of Transportation (FDOT) has determined that it will undertake projects to replace Bridge #934319 (Seminole Drive over the L-16 Canal), Bridge #934403 (Sandalfot Boulevard over the E-1E Canal), Bridge #934904 (New England Boulevard over the E-1 Canal), and Bridge #934419 (El Clair Ranch Road over the L-30 Canal) (Projects); and,

**WHEREAS**, Palm Beach County Board of County Commissioners (BCC) endorsed the Projects at the November 1, 2016 BCC meeting, Resolution R-2016-1571; and

**WHEREAS**, Palm Beach County (County) recognizes these bridges will be replaced and there will be complete road and bridge closures at the Projects for the duration of the construction, and traffic will be detoured to other County streets; and

**WHEREAS**, the FDOT submitted road closure plans for the Projects and received conceptual approval from the Engineering Department's Traffic Division; and

**WHEREAS**, through this Resolution, the FDOT will implement the closures during construction of the Projects; and

**WHEREAS**, the BCC has determined that execution of this Resolution to be in the best interest of the citizens and residents of the County.

**NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY  
COMMISSIONERS OF PALM BEACH COUNTY FLORIDA, THAT:**

1. The foregoing recitals are hereby reaffirmed and ratified.
2. The Mayor is hereby authorized to execute the Resolution.
3. This Resolution will take effect upon its adoption.
