# I. EXECUTIVE BRIEF

**Motion and Title**: **Staff recommends motion to receive and file**: Notification of the cumulative value of additional work to the contract with Colome & Associates, Inc. (R-2016-0252) for the Palm Tran South County Expansion project having reached the \$250,000 cumulative limit threshold.

**Summary:** In accordance with PPM CW-F-050, when the cumulative value of changes or additional work approved by the Lead Department and the Contract Review Committee exceeds \$250,000, the Department is required to notify the Board that it has reached this reporting threshold. With approval of Consultant Service Authorization (CSA) No. 9 for \$66,061 on October 4, 2017 by the Contract Review Committee, the cumulative total of design changes for this project is \$269,061. This item notifies the Board that the cumulative threshold has been reached and is being reset by this notification. The Disadvantaged Business Enterprise cumulative participation for this contract is 55.7%. (Capital Improvements Division) District 7 (LDC)

**Background and Justification**: PPM CW-F-050 titled "Change Order and Consultant Services Authorization Authority for Construction, Engineering and Architectural Contract" provides for authority limits and procedures for changes to project specific consultant contracts. The PPM specifically provides for Board notification when a cumulative limit of \$250,000 of changes to the contract is reached. The PPM states that when this amount is exceeded, the Department will prepare a Board item informing the Board that the limit has been reached. After the item is approved by the Board, the cumulative reporting thresholds are reset.

CSA No. 7 authorized providing pre-engineered guardhouse building design documents, covered patio structure for bus drivers, maintenance building re-roofing and weatherproofing, maintenance building fire alarm replace and infrastructure only for nine (9) car charging stations at the new south parking lot. CSA No. 8 authorized additional geotechnical engineering services for utility locates.


