**Background and Justification:** WUD's Uniform Policies and Procedures require Standard Development Agreements to obtain concurrency for water and/or wastewater service. The terms and conditions for Standard Development Agreements are outlined in the WUD Uniform Policies and Procedures Manual. The BCC delegated the authority to execute various types of Standard Development Agreements, and related documents including Standard Indemnity Agreements to the Department Director including potable water and wastewater agreements (R93-1619); reclaimed water agreements (R96-0228); and additional conditions for potable water, wastewater, and reclaimed water agreements (R2003-0539).

The Agreements have been executed on behalf of the BCC by the Director of WUD in accordance with the authority delegated by the BCC, and are now being submitted to the BCC to receive and file.

A) Standard Potable Water and Wastewater Development Agreement with D.R. Horton, Inc., #01-01242-001 (District 2). The Agreement authorizes the Property Owner located 0.25 miles south of Ranchette Road and Summit Blvd. intersection, 41.00 Equivalent Residential Connections (ERC's) for both water and wastewater for five (5) years.

B) Standard Potable Water and Wastewater Development Agreement with Willie H. Day and Frankie J. Day, #11-01016-000 (District 6). The Agreement authorizes the Property Owner located at the SW corner of Okeechobee Boulevard and Folsom Road, 29.00 ERC's for both water and wastewater for five (5) years.

C) On September 13, 2016, the Board of County Commissioners approved the Contract for WTP 3 and 9 Wellfield Improvements with Florida Design Drilling Corporation (R2016-1163). Change Order No. 1 was approved by the Director of WUD on September 28, 2017 in the amount of \$47,764.00 and provided for a 30-day time extension. Change Order No. 2 was approved by the Contract Review Committee on September 20, 2017 and provided for a 59-day time extension with no cost increases. Change Order No. 3 was approved by the Contract Review Committee on October 18, 2017 and provides for an extension of the Contract by 38-days to offset the time delays due to other work that impacted the ability of the water treatment plant to release a production well to the contractor. The cumulative time extension including Change Orders 1 to 3 is 127 days. County PPM CW-F-050 requires Board notification when the cumulative limit of one hundred twenty (120) days has been reached to reset the applicable time limit approvals.



Ms. Rivera,

Florida Design Drilling Corporation (FDD) is requesting a 38-day time extension to this contract due to time delays incurred as a result of work being performed by another electrical contractor at well 9W-22, a communication issue at 9W-24 and the System 9 water treatment plant (WTP) and work being performed simultaneous by another well contractor at 9W-25.

In review of work complete; FDD has reached the following milestones at System 9:

- Well 18 All well reconstruction and mechanical work complete. In bacteriological clearance process.
- Well 20 Work beginning currently.
- Well 21 Planned to begin after well 18 and/or 23 are cleared.
- Well 22 All well reconstruction and mechanical work complete. Well online, ready for punch list walk through.
- Well 23 All well reconstruction and mechanical work complete. In bacteriological clearance process.
- Well 24 All well reconstruction and mechanical work complete. Well online, ready for final walk through.

FDD incurred the following time delays during this project:

- System 9:
  - Other electrical contractor at 9W-22 After FDD completed all well rehabilitation and mechanical work at 9W-22, well clearance was the next step. FDD was asked by PBCWUD to allow another contractor to complete electrical work in order to facilitate that contractor to complete its (separate) contract before FDD began the well clearance

process. The work by the other contractor was to take 1-2 days. The work and subsequent return of the well to FDD to continue work took 14 calendar days.

- Communication Issues at 9W-24 In late April, 2017 after FDD was completed with 9W-24 rehabilitation and well clearance; the WTP was ready to begin using the well. An antenna issue unrelated to FDD work prevented the WTP from communicating with this well and therefore delayed FDD from starting work at subsequent wells because 9W-24 was not available to the WTP. This communication issue required at least 14 calendar days to resolve. FDD began work at 9W-23 on 5/16/2017.
- Other well contractor at 9W-25 During the outset of the project FDD began work at well 9W-24 on November 8, 2016. It was FDD's understanding that PBC would allow work on two wells at a time per Section 01010, 1.03 D. Within approximately one week after FDD mobilized 9W-24 in mid-November 2016 another well contractor mobilized well 9W-25 and by November 21, 2016 was performing similar well construction / rehabilitation work that FDD performed at 9W-24. In the first time extension request FDD indicated this work by another contractor started December 1, 2016, however the work actually started approximately two weeks earlier, on November 21, 2016. This was additional limited time to only one System 9 well. During this time FDD had crew and equipment available to perform work at the other 9W wells under the 15-035 contract. FDD estimates this delay from November, 21 to December 1, 2016 to be 10 days.

System 9 currently remains critical path, FDD is requesting this time extension based on the specific delays described above at 9W-22, 9W-24 and 9W-25.

As previously discussed, FDD unconditionally understands the necessity of PBCWUD continuing WTP operations at all times. FDD will continue to make every effort to allow that by adjusting our crews and equipment to accommodate.

In response FDD is kindly requesting a time extension of 38 calendar days to the contract to relieve the delays we have incurred due to work by others as described above.
