I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Change Order No. 3 to the contract with Rio-Bak Corporation extending the procurement period of the contract by an additional 35 Calendar Days and no additional cost, for the Wetland Wildlife Hazard Mitigation Phases 3A, 3B, and 4 at North Palm Beach County General Aviation Airport (F45).

Summary: The contract with Rio-Bak Corporation for the Wetland Wildlife Hazard Mitigation Phases 3A, 3B, and 4 at F45 in the amount of \$2,499,634 and 205 Calendar Days was approved by the Board on July 11, 2017 (R-2017-0936). Change Orders 1 and 2 approved under the delegated authority detailed in PPM CW-F-050, extended the contract by an additional 89 Calendar Days and no additional cost. Approval of Change Order No. 3 will extend the contract by an additional 35 Calendar Days with no additional cost, for a total contract time of 329 Calendar Days. The Disadvantaged Business Enterprise (DBE) Goal for this project was established at 21%. Rio-Bak Corporation committed to 22% DBE participation. Countywide (AH)

Background and Justification: The contract includes a procurement period of 30 Calendar Days to allow the contractor to issue subcontracts, complete required submittals and obtain access/ID badges for critical facilities. This project is primarily an earthwork project. The existing wet conditions of the soil following the rainy season and impacted further by Hurricane Irma have hindered the start of construction activities. Approval of Change Order No. 3 to extend the procurement period by 35 Calendar Days and no additional cost, will allow the contract to begin during the dry season. The change order is being brought to the Board for approval due to the time extension pursuant to PPM CW-F-050.

It is a requirement of this contract that items listed in Attachment No. 1 to the Bid Form are to be sequenced and scheduled as herein stipulated.

PROJECT NAME: Wetland Wildlife Hazard Mitigation Phases 3A, 3B, and 4

- 1. The Contractor may not proceed with the project without prior written authorization from the Owner. This authorization shall be called **NOTICE TO PROCEED**.
- 2. Due to the Owner's constraints and overall project completion, the Contractor shall substantially complete the project within 175 calendar days from the Notice-to-Proceed. Should the contractor fail to complete the time-limited work by the timeframes specified, the Owner will suffer damages and will be entitled to LIQUIDATED DAMAGES in the amounts specified below per calendar day past the contract completion date.
- 3. Phase 1: Procurement. All necessary submittals including but not limited to construction schedule, specification items to complete first phase of work, Safety Plan Compliance Document (SPCD), Quality Control Plan (QCP), sample pay application; submittal approvals; permits; and other incidentals including in place subcontracting agreements for bid subcontractors or qualified alternates, necessary to the start of construction work in this Contract shall be completed and accepted within the number of Calendar Days referenced below from the date of Notice to Proceed. This time is inclusive of Owner and Engineer review time not to exceed twenty-one (21) Calendar Days for each submittal and subsequent resubmittal as necessary. Should the Contractor fail to complete the work by the timeframe specified, the Owner will suffer damages and will be entitled to Liquidated Damages in the amounts specified.
- 4. Phase 2: Construction. Shall be for a period of one hundred and forty five (145) Calendar Days from the completion and approval of Phase 1 to the issuance of the Certificate of Substantial Completion. Should the Contractor fail to complete the work by the timeframe specified, the Owner will suffer damages and will be entitled to Liquidated Damages in the amounts specified.
- 5. Phase 3: Final Completion. Shall be for a period of thirty (30) Calendar Days from the completion and approval of Phase 2. Should the Contractor fail to complete the work by the timeframe specified, the Owner will suffer damages and will be entitled to Liquidated Damages in the amounts specified.

Dear Ms. Portnoy,

Due to excessive rainfall to our region we are formally asking for an extension to our start of construction date to **January 8, 2017**.

Due to the excessive flooding and high water table it would be impossible to perform our scope of work. The following field conditions would hinder any progress for reasonable completion.

- Excessive flooding deters any clearing practices to take place.
- According to closest SFWMD rain station gauge located at C18 W-R we have received 28.73" of rainfall from 9/01/2017 through today. Which equates to +/- 75% of total rainfall for 2017. (See attachment A)
- Due to current high water table, even if clearing were possible, unsuitable investigation would not be possible, stripping's would be completely saturated, stockpiling, and handling an impossibility, proof roll would not be possible. Etc.

As stated above we feel the date of **January 8, 2017** is a conservative anticipated date barring unseasonable high levels of rain in December to begin construction activities. It is of our opinion that all above work related restraints due excessive rainfall shall be subsided with in that time frame.

Please see attached pictures of existing control structure with bleeder at a 16.47, standing water is current at an 18.51 elevation where proposed staging/stockpile area at 3A-B


