I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Consultant Services Authorization (CSA) No. 1 for the Priority Aerial Canal Crossing Improvements Phase 2 Project (Project) with Mock, Roos & Associates, Inc., in the amount of \$243,900.

Summary: On June 20, 2017 the Board of County Commissioners (BCC) approved the Water Utilities Department (WUD) Contract with Mock, Roos & Associates, Inc., (R2017-0818). CSA No. 1 provides for engineering services relating to the surveying, design and permitting for the replacement/rehabilitation of nine (9) aerial canal crossings. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance is 15% overall. The Contract with Mock, Roos & Associates, Inc., provides for SBE participation of 98% overall. CSA No. 1 includes 75.63% overall participation. The cumulative SBE participation, including CSA No. 1 is 75.63% overall. Mock, Roos and Associates, Inc., is a Palm Beach County company. The Project is included in the FY 18 Capital Improvement Plan adopted by the BCC. (WUD Project No. 17-077) District 5 and 6 (MJ)

Background and Justification: WUD is currently implementing projects to rehabilitate the existing water distribution and wastewater collection system that will increase system capacity, improve system pressures, increase hydraulic efficiency and overall system reliability. WUD has identified nine (9) aerial crossing locations that are in need of rehabilitation within the WUD service area. CSA No. 1 provides for the work necessary to undertake the rehabilitations.





Priority Aerial Canal Crossing Improvements Phase 2

WUD Project No.: 17-077

INTRODUCTION

Palm Beach County (COUNTY) entered into an agreement entitled Contract for Engineering/ Professional Services – Utility Distribution & Collection System Engineering Services, Water Utilities Department (WUD) Project No.: 17-005 (CONTRACT) with Mock, Roos & Associates, Inc. (CONSULTANT) to provide engineering services for various general activities on <u>June 20</u>, <u>2017</u> (Reference Document <u>R2017-0818</u>). This Consultant Service Authorization will be performed under that CONTRACT.

BACKGROUND

The COUNTY is currently implementing projects to rehabilitate the existing water distribution and wastewater collection system and has identified eight (8) aerial canal crossings which require replacement/rehabilitation and one (1) location for construction of a new aerial canal crossing. **ATTACHMENT G** illustrates the location of each crossing. A summary of the location, description, and proposed improvements for each of the crossings are summarized in **Table 1**:

SCOPE OF SERVICES

CONSULTANT shall proceed with the surveying, design, permitting, bidding services, and community outreach support services necessary to prepare detailed drawings for the project in accordance with the COUNTY's Minimum Engineering and Construction Standards and applicable permitting agencies. Further description of the anticipated Scope of Services includes the following:

Task 1 - Surveying Services

1.1. Preparation of a Survey Basemap

CONSULTANT will coordinate surveying services to provide land surveying of existing aerial crossings and surrounding area, vertical and horizontal control and data, inclusive of canal cross section(s) at each of the sites. CONSULTANT shall coordinate the preparation of a Survey Basemap for preparation of CONSULTANT's construction drawings. Topographic survey shall be in the state plane coordinate system of North American Datum 1983, 90 Adjustment (NAD83/90) horizontally and the North American Vertical Datum of 1988 (NAVD88) vertically.

Survey Basemap will include the following:

- 1. Depiction of property lines and right-of-way lines based on the Palm Beach County Parcel Lines as downloaded from Palm Beach County GIS Department.
- 2. A minimum of two Horizontal and Vertical Control Points at each aerial crossing site.
- 3. Topographic survey data depicting canal edges for the top of bank and edge of water, pavement edges, above ground and visible utilities such as water valves, fire hydrants, pipe fittings, top of pipes as visible at aerial crossings, support decks and columns for existing aerial crossings, storm structures (catch basins /manholes / outfall pipes), sanitary manholes, electric hand holes, etc., together with paint marks /flags as established by subsurface scanning methods depicting the approximate location of the said subsurface facilities at ground level and topographical spot elevations within the general limits of the proposed facilities as discussed at the onsite observation of each site.
- 4. GPS coordinates for all field located water meter and valve box locations.
- 5. Canal cross sections at pile supported canal crossings.

1.2. Sketch and Legal Descriptions

CONSULTANT will provide Title Search and Legal Sketch and Descriptions for up to four proposed Utility Easements for parcels to be determined during the 60% design phase.

Task 2 – Engineering Services 2.1. Record Drawings Review

The CONSULTANT shall research, review and study record information, GIS database information, and other pertinent information of the existing facilities within the project limits that are provided by the COUNTY.

2.2. Project Meetings and Site Visits

The CONSULTANT shall attend up to four meetings (kick off, 30%, 60%, and 90%) with COUNTY to review design progress. CONSULTANT will lead meetings and provide a meeting agenda. Meeting minutes to be provided within three (3) calendar days of each meeting. These meetings will be exclusive of other meetings identified herein.

CONSULTANT shall perform up to two site visits at each aerial crossing in conjunction with the utility coordination and subsurface exploration.

2.3. Utility Coordination

Produce preliminary Engineering Basemap incorporating the Survey Basemap and other known existing infrastructure identified in the area based on the information provided by the COUNTY. Submit preliminary Engineering Basemap to local utilities for mark-up of their existing utilities. CONSULTANT will coordinate with each utility and provide follow-up communications as necessary. Utilities include, but not limited to, telephone, cable, gas, forcemains, and watermains. Incorporate utility mark-ups into Engineering Basemap and produce preliminary Base Sheets. CONSULTANT will submit preliminary Base Sheets to COUNTY for review and comment. CONSULTANT will incorporate COUNTY comments into Final Base Sheets.

2.4. Subsurface Utility Exploration

CONSULTANT will coordinate geotechnical/testing laboratory services to provide two subsurface soils investigation (SPT boring to 50 feet below grade) at crossing locations where it is determined new pile supports are required. (12 Soil Borings).

CONSULTANT will provide and coordinate the underground location services to confirm existing subsurface utility locations, as necessary to advance engineering design to 60% completion. Utilities will be located by an air/vacuum excavation method (including temporary surface restoration). A total of 54 air/vacuum excavations (six per site) are included.

2.5. Preliminary Design and Review

Develop and submit preliminary construction drawings using Final Base Sheets. These drawings will provide graphic representation of the conceptual design intent of the preliminary (30%) design, alignment, and layout at each of the locations. These drawings will include conceptual layouts on plan sheets only (no profile) and will constitute the 30% completion level submittal for review and comment. Advancement of construction drawings by CONSULTANT beyond 30% completion will be based on concurrence from COUNTY regarding the agreed-to design intent at each of the sites.

CONSULTANT will meet with COUNTY to review the 30% completion level submittal, respond to questions/comments, and incorporate final agreed to comments. CONSULTANT will compile and address all comments on the COUNTY'S Quality Review Form.

2.6. 60 Percent Design and Review

CONSULTANT shall prepare and submit construction drawings at the 60% completion level. CONSULTANT shall provide three (3) full size sets and two (2) half size sets. These drawings will generally consist of a cover sheet, key sheet, plan and profile sheets, structural sheets and detail sheets. CONSULTANT will provide and coordinate structural engineering services relative to all crossings as needed. CONSULTANT shall provide a list of specification sections.

CONSULTANT shall meet with COUNTY to review 60% completion submittal, respond to questions/comments, and incorporate final agreed to comments. CONSULTANT will compile and address all comments in the PBCWUD Quality Review Form.

2.7. 90 Percent Design and Review

CONSULTANT shall prepare and submit construction drawings including structural sheets at the 90%. CONSULTANT shall provide three (3) full size sets and two (2) half size sets. CONSULTANT will also provide two (2) copies of the draft specifications and an Opinion Probable Construction Cost (OPCC) along with the schedule of values.

CONSULTANT shall meet with COUNTY to review 90% completion submittal, respond to questions/comments, and incorporate final agreed to comments. CONSULTANT will compile and address all comments in the PBCWUD Quality Review Form.

2.8. 100 Percent Design and Review

CONSULTANT shall provide final design phase deliverables consisting of construction drawings, specifications, OPCC, and other documents in paper copies, PDF files, and AutoCAD and Microsoft Word files. CONSULTANT shall provide three (3) full size sets and two (2) half size drawing sets. CONSULTANT will also provide two (2) copies of the draft specifications and an Opinion Probable Construction Cost (OPCC) along with the schedule of values.

Task 3 – Permitting Services

3.1 Permitting with Regulatory Agencies

Research and document permitting requirements for each of the locations. Permitting will be on a site-by-site basis as each location may require permitting from several/different agencies, which may include Army Corps of Engineers (ACE), Palm Beach County Health Department (PBCHD), South Florida Water Management District (SFWMD), Lake Worth Drainage District (LWDD), Belle Glade, Royal Palm Beach, Palm Beach County Fire Rescue, Palm Beach County Engineering, Florida Department of Transportation (FDOT), FDOT Turnpike Authority, and South Florida Conservancy District (SFCD). CONSULTANT shall perform preliminary permitting investigation.

In addition to preparing the permit applications for appropriate regulatory agencies, CONSULTANT shall assist the COUNTY in consultations with the appropriate authorities. CONSULTANT services shall include the following:

- 1. Attend meetings with each of the regulatory agencies during review of the final permit applications as required.
- 2. Respond to up to two (2) request(s) for additional information from each regulatory agency.
- 3. Provide COUNTY with one (1) set of approved plans from permitting agencies, as may be applicable.
- 4. Prepare and submit permit applications (COUNTY to provide hydraulic calculations/data as may be required by Health Department or others).

COUNTY will be responsible for all permit application fees.

Task 4 – Bidding Services

4.1. Bidding Assistance

The CONSULTANT will perform, as required by the COUNTY, the following services during the bidding and negotiating phase:

- 1. Provide Technical Specifications and Construction Drawings to be included in bid documents
- 2. Assist with pre-bid meeting agenda, attend pre-bid meeting and site visit, and review and comment on meeting minutes before issuance to plan holders
- 3. Provide answers to questions bidders may have concerning the bid documents and prepare draft addenda as necessary to clarify the bid documents
- 4. Attend the bid opening and prepare the bid tabulation form
- 5. Evaluate bids and prepare a recommendation of award

Task 5 – Community Outreach Services

5.1 Community Outreach Support

The CONSULTANT shall assist the COUNTY and their Community Outreach Consultant towards the acquisition of the easement(s) required for the project, the pre-construction public notices and community outreach meeting. The CONSULTANT services include coordination and correspondence with the COUNTY and their Community Outreach Consultant, preparation of exhibits and attending up to two (2) community outreach meetings.

The CONSULTANT shall provide assistance to the County in accordance with the attached budget for a project total of \$243,900.00.

SBE PARTICIPATION

1. SCHEDULE 3(A) – Professional Services Activity Report

This form shall be submitted by the prime contractor with each payment application when SBE and/or M/WBE sub-consultants are utilized in the performance of the contract. This form shall contain the names of all SBE and M/WBE sub-consultants, specify the sub-consultants dollar amount for each sub-consultants and show amount drawn and payments to date issued to sub-consultants.

2. SCHEDULE 4 – SBE-M/WBE Payment Certification

A schedule 4 for each SBE and/or M/WBE sub-consultant shall be completed and signed by the proposed SBE and/or M/WBE after receipt of payment from the prime. When applicable, the prime shall submit this form with each application submitted to the county for payment to document payment issued to a sub-consultant in the performance of the contract.

SBE participation is included in the **ATTACHMENT F** under this authorization. The attached Schedule 1 defines the SBE applied to this CSA/Contract and Schedule 2 establishes the SBE contribution from each subcontractor (Letter of Intend to perform as an SBE).


