I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: A Notice requesting Airport Facilities and Systems Planning, Design, Engineering and Construction Management Professional Services for Vertical Facility Design, such as Architectural, Mechanical, Electrical, Structural and Landscaping Design of Airport-related and Ancillary Facilities for the Palm Beach County Department of Airports.

Summary: In accordance with Board established procedures referencing the Consultant's Competitive Negotiation Act (CCNA), this notice is required to be processed as the initial step of the selection process to comply with Florida Statutes 287.055 (Public Announcement in a Uniform and Consistent Manner). The Department of Airports will execute an advertisement and selection process for these services. A Disadvantaged Business Enterprise (DBE) Goal of 18% has been established. <u>Countywide (AH)</u>

Background and Justification: In order for the Department of Airports to implement the Airports' Master Plans, as previously approved by the County Commission, Professional Consulting Services will be required. Services to be provided by the selected firm include but are not limited to: Airport Facilities and Systems Planning, Design, Engineering and Construction Management Professional Services for Vertical Facility Design, such as Architectural, Mechanical, Electrical, Structural and Landscaping Design of Airport-related and Ancillary Facilities for the Palm Beach County Department of Airports.

Airport Facilities and Systems Planning, Design, Engineering and Construction Management Professional Services for Vertical Facility Design, such as Architectural, Mechanical, Electrical, Structural and Landscaping Design of Airport-related and Ancillary Facilities for the Palm Beach County Department of Airports.

Pursuant to 49 CFR Part 26, the County will provide contracting opportunities for Disadvantaged Business Enterprises (DBE's). Palm Beach County's minimum DBE goal is 18%.
