I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

A) adopt a Resolution authorizing a Release of Rights of Entry and Exploration for minerals for Habitat for Humanity of South Palm Beach County, Inc. (Habitat) owned properties located on NE 2nd Street between Seacrest Blvd. and E. Martin Luther King Jr. Blvd. in Boynton Beach, and

B) approve a Release of Rights of Entry and Exploration.

Summary: The Board approved the conveyance of three (3) surplus properties to the City of Boynton Beach, via Florida Statutes Section 197.592(3). On December 4, 2017, the City of Boynton Beach conveyed these properties to Habitat. Habitat is requesting that the County release the rights of entry and exploration for minerals from these properties in order to render the properties marketable. Staff has no reason to believe that there are any minerals of significant market value. **(PREM) District 7 (HJF)**

Background and Justification: On March 17, 1998, (R98-364), the Board approved the conveyance of two (2) surplus properties to the City of Boynton Beach. On July 11, 2000 (R2000-0946), the Board approved the conveyance of one (1) surplus property to the City of Boynton Beach. These properties are adjacent to each other and are located on NE 2nd Street in Boynton Beach. In December 2017, the City donated the three (3) properties to Habitat for the purpose of constructing new homes and is requesting that the County release all rights of entry and exploration for mineral rights in the properties in order to improve the marketability of the properties. The County deeds to the City of Boynton Beach do not specifically reserve mineral rights with rights of entry and exploration on these properties. In order to satisfy the attorneys for Habitat, Staff is recommending approval of this Release.



RESOLUTION THE \mathbf{OF} **BOARD** OF COUNTY **COMMISSIONERS PALM BEACH OF** FLORIDA, **AUTHORIZING** THE RIGHTS OF ENTRY AND EXPLORATION RELATING MINERAL AND **PETROLEUM** RESERVATIONS; AND **PROVIDING FOR** EFFECTIVE DATE.

WHEREAS, on March 17, 1998 (R98-364), the Board of County Commissioners of Palm Beach County approved the conveyance of two (2) properties to the City of Boynton Beach as recorded in Official Records Book 10326, Page 1867 and Official Records Book 10326, Page 1868; and

WHEREAS, on July 11, 2000 (R2000-0946), the Board of County Commissioners of Palm Beach County approved the conveyance of one (1) property to the City of Boynton Beach as recorded in Official Records Book 11919, Page 1547; and

WHEREAS, on December 4, 2017, the City of Boynton Beach conveyed these properties to Habitat for Humanity of South Palm Beach County, Inc. ("Habitat"); and

WHEREAS, Habitat has requested that the rights of entry and exploration relating to phosphate, mineral, metals and petroleum rights be released from these properties in order to render title to such properties marketable; and

WHEREAS, the Board of County Commissioners of Palm Beach County hereby agrees to release any and all rights of entry and exploration relating to phosphate, mineral, metals and petroleum rights arising pursuant to those certain instruments recorded in Official Records Book 10326, Page 1867, Official Records Book 10326, Page 1868 and Official Records Book 11919, Page 1547.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. Recitals

The foregoing recitals are true and correct and incorporated herein by reference.

Section 2. <u>Authorization to Re-convey Real Property</u>

The Board of County Commissioners of Palm Beach County shall release any and all rights of entry and exploration relating to phosphate, mineral, metals and petroleum

rights arising pursuant to those certain instruments recorded in Official Records Book 10326, Page 1867, Official Records Book 10326, Page 1868 and Official Records Book 11919, Page 1547 by execution of the Release of Rights of Entry and Exploration Relating to Phosphate, Minerals, Metals, and Petroleum Reservations attached hereto as Exhibit "A".

Section 3. Conflict with Federal or State Law or County Charter

Any statutory or Charter provisions in conflict with this Resolution shall prevail.

Section 4. Effective Date

The provisions of this Resolution shall be effective immediately upon adoption
