I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Amendment No. 14 to the Construction Manager (CM) at Risk Contract with The Morganti Group, Inc. for CM at Risk Services for Task M-33: Concourse B Holdroom and Lobby Furniture at Palm Beach International Airport (PBIA) in the amount of \$3,117,900 and 240 Calendar Days.

Summary: The Contract with The Morganti Group, Inc. for CM at Risk Services for Terminal Improvements at PBIA was approved by the Board on June 4, 2013 (R-2013-0663). The Contract is for 2 years with 3 one (1) year renewal options and is a task order based contract for CM at Risk Services at PBIA. The Board exercised the first one-year renewal option on May 5, 2015 (R-2015-0550); the second one-year renewal option on May 3, 2016 (R-2016-0557) and the final one-year renewal option on May 2, 2017 (R-2017-0538). The Morganti Group, Inc. is a Danbury, Connecticut, based firm; however, the work will be directly managed by their southeast regional office in Palm Beach County. The contract value to date is \$24,855,225. Approval of Amendment No. 14 in the amount of \$3,117,900 and 240 Calendar Days will provide funds to complete Task M-33: Concourse B Holdroom and Lobby Furniture at PBIA. Local funds are being utilized to fund this project. The Disadvantaged Business Enterprise (DBE) goal for this contract is 13%. The total to date participation for this contract is 16%. **Countywide (AH)**

Background and Justification: This project is part of the ongoing terminal improvement/ enhancement project at PBIA. Over the past five years, the County has initiated multiple projects to enhance and improve the facilities at PBIA including new signage, flooring, security improvements, restroom renovations and replacement of the airline gate podiums in Concourses B and C. Approval of Amendment No. 14 will enable the Department of Airports to begin the replacement of furniture in the hold rooms of Concourse B and the lobby on the second level of the terminal at PBIA. The scope in this project includes the first phase of furniture replacement for the terminal. The existing chairs in the hold rooms of Concourse B will be replaced with a variety of new seating groups with charging stations integral to the furniture. The hold rooms will also include a number of work bars/tables also with charging stations. In addition, the new furniture in the lobby area on the second level of the terminal will be enhanced with wall partitions and lighting to exhibit the work of local artists. The scope includes electrical Infrastructure to support the new furniture. Builder's Risk Insurance for this task will be provided by the Contractor.
