I. EXECUTIVE BRIEF										
Motion and Title: Staff recommends motion to:										
A) ratify the Mayors signature of approval for the Department of Health and Human Services, Substance Abuse and Mental Health Services Administration, Offender Reentry Program Grant Application for \$2,125,000 from October 1, 2018 through September 30, 2023, to facilitate the reduction of recidivism in Palm Beach County; and										
<b>B) authorize</b> the County Administrator or her designee to execute the grant award and amendments and to submit electronic reports after approval of legal sufficiency by the County Attorney's Office and within budget allocations.										
<b>Summary:</b> Palm Beach County (PBC) facilitates the successful reintegration of ex-offenders as they return to Palm Beach County. This application, if funded, would enhance the existing reentry program by expanding treatment programs for adults diagnosed with co-occurring substance abuse and mental disorders. <b>No County matching funds are required for this grant.</b> Countywide (LDC)										
<b>Background and Justification:</b> Palm Beach County has developed a Strategic Plan for providing effective and coordinated reentry services to those returning from incarceration. The RESTORE Initiative is a product of this plan. The goal is to reduce the recidivism rate by 50% over 5 years for the target population (prisoners convicted in and returning to Palm Beach County). The program is intended to reduce recidivism among transitioning offenders as well as reduce future victimization, enhance public safety and improve the quality of life in Palm Beach County.
