# I. EXECUTIVE BRIEF

**Motion and Title**: **Staff recommends motion to approve:** Change Order No. 18 to the contract with Hedrick Brothers Construction Company, Inc. (R-2014-0922) decreasing the Guarantee Maximum Price (GMP) for the Airport Center Building 2 Renovations project in the amount of \$200,838.50.

**Summary:** On November 14, 2015, the Board approved Amendment No. 1 to the contract with Hedrick Brothers Construction Company, Inc. (R-2015-1556) in the amount of \$10,836,968 for the construction of the both interior and exterior renovations to the Airport Center Building 2 to accommodate offices of the Tourist Development Council and related agencies as well as several divisions of the Sheriff's Administrative Services including Central Records, Human Resources, Risk Management and Labor relations. There is \$200,838.50 remaining as a result of sales tax savings, and unused contractor contingency. The Small Business Enterprise (SBE) goal established by the SBE Ordinance for this contract is 15%. Hedrick Brothers Construction Co., Inc.'s SBE participation for this change order is 0%. Including this change order, Hedrick Brothers Construction Co., Inc.'s overall SBE participation is 44.9%. This work was funded from bed tax for Tourist Development Council and Fund 3076 – 66.4M Public Improvement Revenue Bonds, Series 2015A for Palm Beach County Sheriff's Office and funds will be returned to the project budget. (Capital Improvements Division) <u>District 2</u> (LDC)

**Background and Justification**: On July 1, 2014, the Board approved a contract with Hedrick Brothers Construction Co., Inc. for preconstruction services. Amendment No. 1 (R2015-1556) authorized Hedrick Construction Co., to provide for the construction of both the interior and exterior renovations. After reconciliation of the final construction costs, a credit of \$200,838.50 is being returned to the County.
