

### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: a budget transfer of \$840,000 from General Fund contingency to the Supervisor of Election (SOE).

Summary: The SOE's Fiscal Year (FY) 2018 budget did not include funding for a special election. The cost of the special election was \$840,000 and the State will reimburse the SOE for the election; however, it is not likely to occur in the current fiscal year. Funds are needed to continue normal operations. Countywide (DB).

Background and Policy Issues: The County is required to the fund the SOE operations. Any funds not spent during the fiscal year are returned to the County as excess fees.




