Motion and Title: Staff recommends motion to approve: Change Order No. 3 with Community Asphalt Corp. (CAC) in the amount of \$16,721.74, including a time extension of 153 days, for the construction of the drainage system on Old Dixie Highway from Park Avenue to Northlake Boulevard, R2016-1316 (project).

SUMMARY: Approval of Change Order No. 3 will allow CAC to construct the drainage system required for the project, and will include a time extension of 153 days due to unforeseen field conditions. Per PPM CW-F-050, this change order exceeds the 90-day threshold relating to staff approvals of change orders to contracts, and requires the Board of County Commissioners' approval. The Small Business Enterprise (SBE) goal for all contracts is 15%. CAC proposed 15.6% SBE participation. Their SBE participation for this change order is 0.0% and their cumulative SBE participation to date is 4.4%, however, CAC should be able to meet their SBE goal by the end of the contract. District 1 & 7 (LBH)

Background and Justification: During construction of the project, it was discovered that there was a conflict between the existing Seacoast Utility Authority's force main and the proposed new drainage system. It was also determined that the bid documents did not include a bid item for adjustment of the existing force main, resulting in the need for additional work, as well as time to accomplish this additional work.



### Good Afternoon Brian,

Please see the attached page 38 that reflects the area where the 6" Force Main is shown in direct conflict with the proposed 42" RCP outfall pipe. Within the Bid Tab item #92 calls out for Adjust 6" DIP Water Main pipe but this would be incorrect as this reflects as a Force Main within the plans. Further pricing would need to be provided if this is an existing Force Main pipe, then different style pipe will be needed as well as methodology of draining the pipe when we perform the deflection. Please get this into Steve for his review and direction on what would need to be done in this area and it appears that the deflection could be accomplished deflecting above the drainage pipe and maintain the 30" to 36" cover for SUA. We will also need the Force Main atlas of this area so that we can see how much Force Main would need to be evacuated in order to accomplish this work as well. If you have any questions on this RFI, please don't hesitate to contact me.

The pipe in question is a 6" Force main as shown on sheet 38. PIN 52 on sheet 2 and Bid Tab #94 both call out to "Adjust 6" DIP WM" which should have been stated as " Adjust 6" DIP FM".

In discussion with Seacoast we prefer to keep the deflection below the proposed drainage pipe as the detail shows on sheet UTV-2 unless the contractor can show how the minimum cover can be maintained outside of the proposed 42" pipe area.

Good Afternoon Brian,

In review of the response below from the County this will be a change order for the Force Main as the bid tab clearly called out a water main deflection and there will be different style pipe as well as methodology of this proposed deflection. With this in mind, there are numerous ways to accomplish this deflection and / or conflict area. They are as follows listed from the most expensive route to the most economical route in our opinion:

- 1. Deflect Force Main above the proposed drainage but 6" line will need to be evacuated, valves placed, temporary stabilized rock road approx. 1400 LF long to get the Vac trucks to the location of the deflection and interrupting service on this line for approx. 6 to 8 hour window.
- Placement of line stops on each side of the drainage pipe and deflect the pipe over the drainage, evacuation of force main (minimal), temporary road for Vac truck to gain access to the location of the deflection and possible service interruption as were not sure how this line is feed or received.

Attachment "D" (Page 2 of 2) 3. Placement of Conflict Structure with casing pipe for the force main to go thru the drainage manhole which would avoid any service interruption, no deflection nor temporary rock roadway would be necessary.

Please send this into the County and SUA for their direction on this matter so that we can price accordingly depending on the direction they would like us to proceed. If there are any questions that you may have on any of this, please don't hesitate to contact me.


