RESOLUTION NO. R-2018-

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, CHANGING THE STREET NAME OF ESCONDIDO WAY W TO ARA DRIVE, LOCATED IN TIMBERS OF BOCA, PLAT BOOK 37, PAGES 156 - 158.

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, is authorized under Section 336.05, Florida Statutes, to name and rename streets and roads lying outside the boundaries of any incorporated municipality; and

WHEREAS, the Board of County Commissioners of Palm Beach County, Florida, has, by Resolution No. R-74-183, as amended and supplemented by Resolution No. R-91-1145, adopted a system of street naming and numbering for Palm Beach County; and

WHEREAS, the Administration Division of the Palm Beach County Planning, Zoning and Building Department has reviewed the request and finds that the proposed name, Ara Drive, does not duplicate any other street name in Palm Beach County; and

WHEREAS, the road which will be renamed has no addresses that will be affected by the change; and

WHEREAS, Jeanette Kamciyan, a homeowner, has paid all application fees to process the street name change; and

WHEREAS, the Planning, Zoning and Building Department has reviewed the proposed street name change and finds this request consistent with adopted County policy and procedures for street name changes and that the change meets all specified conditions.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

- 1. Escondido Way W, located in the unincorporated area of Boca Raton, being the entrance road into the community of Timbers of Boca, is hereby changed and the street shall be known as Ara Drive. This road is delineated on the accompanying map and the resolution shall be recorded in the Public Records of Palm Beach County.
- 2. All appropriate agencies shall be notified by the Palm Beach County Planning, Zoning and Building Department of such official change.
- 3. The Clerk & Comptroller shall indicate the street name changes on the affected plat and/or plats.

Attached you will find the documents required to submit a "Vanity Street Name Change" as follows:

- 1. Petition to Change Street Name
- 2. Affidavit
- 3. Property Appraiser Map

As the Map demonstrates there are no property owners on the strip known as Escondido Way West that would be affected by the proposed name change. All houses that abut this street have Chinaberry Drive as their address. In fact there are no property owners in the Timbers of Boca Development that have Escondido Way as their street address.

The exact location of the street being requested for a name change is Escondido Way West between Lyons Road and Chinaberry Drive, which is located within the Timbers of Boca Development. This name change would not create confusion, if anything it would create more clarity. Escondido Way East runs east of Lyons Road and extends into the development known as Escondido. Renaming the strip known as Escondido Way West located in the Timbers of Boca Development to "Ara Drive" would give it its own distinctive name, independent of the Escondido Development across the street.

Ara is the name of my son, who was born and raised in this neighborhood. I have been a homeowner in the Timbers for over 36 years. Ara's life was abruptly taken at the age of 27 in a motor vehicle accident at the entrance to the Timbers of Boca. It would honor his memory to have a small street within the neighborhood that he lived in until his untimely death named after him.

Many neighbors have suggested that an appropriate and legitimate memorial be erected to honor Ara and his helping and kind nature. Moreover, it would give his mother and his sisters some solace, in that he will not be forgotten.
