I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Reappointment of Eric Malkin as an At-Large member to the Fair Housing/Equal Employment Board (FH/EE Board) for a term beginning on October 1, 2018 through September 30, 2021.

Summary: The FH/EE Board is comprised of nine (9) members consisting of seven (7) district appointments and two (2) at large members. Eric Malkin is an At-Large member of the FH/EE Board. He was appointed to the board on January 9, 2013. Mr. Malkin has expressed an interest in reappointment and has met the attendance requirement during his current term. The FH/EE Board serves as a quasi-judicial body empowered to hear and decide upon the merits of employment and housing discrimination complaints investigated by the Office of Equal Opportunity. The board's nine (9) seats are currently filled. The diversity count including this reappointment is Caucasian: 6 (67%) and African-American: 3 (33%). The gender ratio (female: male) is 1:8. This nominee is a Caucasian male. Countywide (DO)

Background and Justification: The Board of County Commissioners (BCC) enacted Ordinances 95-31 and Ordinance 90-1, as codified in Sections 2-261 through 2-313 of the Palm Beach County Code and Sections 15-36 through 15-64, respectively, establishing the FH/EE Board. The Ordinances requires that the appointees should be a Palm Beach County resident and reflect, to the greatest extent possible, representation from the protected groups identified in the Ordinances and who have experience and interest in equal opportunities. Pursuant to the PPM regarding board appointments, staff requested the Mayor and members of the BCC submit nominees to fill this At-Large vacancy. The board meets quarterly.
