I. EXECUTIVE BRIEF

Motion and Title:

Staff recommends motion to receive and file proof of publications: "Unclaimed Monies" advertised by the Clerk & Comptroller of Palm Beach County.

Summary:

Pursuant to F.S. 116.21, the Clerk advertised certain unclaimed monies held which are subject to forfeiture to Palm Beach County. Florida Statutes 116.21 requires that the proof of publication "shall be filed and recorded in the minutes of the County Commission of such county."

Background and Justification:
