I. EXECUTIVE BRIEF

Staff recommends motion to approve: The First Amendment to the Motion and Title: Agreement (R2017-1633) with Discover Palm Beach County, Inc. (Discover) for the provision of services under the County's Tourist Development Plan during the period October 1, 2018 through September 30, 2019 in the amount of \$17,100,000 in contractual services and \$2,815,246 in indirect costs and reserves for a total of \$19,915,246. This will be the second year of a five-year agreement.

Summary: The First Amendment to the Agreement updates for Fiscal Year 2019 Exhibit "A" – Annual Budget, Exhibit "H" - Performance Measures, and Exhibit "K" - Organizational Chart, to be applied in Fiscal Year 2019. Indirect cost and reserves of \$2,815,246 are included for a total budget of \$19,915,246. An increase of \$215,000 will be added to Discover's cash advance for FY2019 for a total cash advance of \$2,000,000. These exhibit changes have been reviewed and approved by the TDC Finance Committee and TDC Board. (TDC) Countywide (DW)

Background and Justification: Under the current Agreement, Discover develops and implements an Annual Tourism Marketing Plan for the County. All expenditures by Discover under the contract must be made in accordance with the Operating Budget included as Exhibit "A" to the contract, from funds appropriated annually by the County. The new Agreement adopts a new Exhibit "A" (Annual Budget), as well as a new Exhibit "H" (Performance Measures), to apply during Fiscal Year 2019. The First Amendment to the Agreement adds three additional support staff to Exhibit "K" (Organization Chart) to conform to Discover's budget. An increase of \$215,000 will be added to Discover's cash advance for FY2019 for a total of \$2,000,000 for operational expenses.

FIRST AMENDMENT TO THE AGREEMENT BETWEEN PALM BEACH COUNTY ON BEHALF OF THE TOURIST DEVELOPMENT COUNCIL AND DISCOVER PALM BEACH COUNTY, INC.

THIS FIRST AMENDMENT is made and entered into this ______ day of ______, 2018, to the Agreement dated October 17, 2017, (hereinafter referred to as the "Agreement") (R2017-1633), by and between Palm Beach County, a political subdivision of the State of Florida, by and through its Board of County Commissioners (hereinafter referred to as "COUNTY"), and Discover Palm Beach County, Inc. (hereinafter referred to as "DISCOVER").

WITNESSETH:

WHEREAS, the COUNTY and DISCOVER entered into the Agreement whereby DISCOVER develops and implements an annual marketing plan to promote, advertise and optimize Palm Beach County tourism; and

WHEREAS, the COUNTY has identified an increase to DISCOVER's cost advance for FY2019 to be allocated to and expended by DISCOVER in its efforts to promote, market and advertise Palm Beach County tourism under the Agreement; and

WHEREAS, the Agreement requires an amendment to provide for certain revised DISCOVER Exhibits; and

WHEREAS, the parties have agreed that this Amendment is in the best interest of DISCOVER and the COUNTY'S tourism promotion program.

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the parties agree as follows:

- 1. Exhibit A of the Agreement is hereby deleted in its entirety and replaced with a new Exhibit A, FY 2019 Annual Budget, Exhibit "H" Performance Measures, Exhibit "K" Organizational Chart for salaries, positions and titles, all attached hereto and made a part hereof.
- 2. An additional \$215,000 will be added to DISCOVER's cash advance for FY 2019. In addition, indirect cost and reserves totaling \$2,815,246 are included for a total budget of \$19,915,246.
- 3. Section 4, <u>Operations/Funding Agreement</u>, Subsection C, <u>Operating Budget/Expendable Budget Supplies/Funds Availability Procedure for Handling Income and Expenses</u>, Paragraph 4) <u>Discover Operating Account</u>, 1st sentence, is hereby amended to read:
 - 4) Prior to the Commencement Contract Date, the COUNTY will advance up to a maximum of one and one-half (1.5) months of personnel costs and sixty (60) days of

budgeted operating expenses for deposit into the Agency Operating Account in order to fund operations of DISCOVER.

- 4. This Amendment shall become effective when executed by the parties hereto.
- 5. All other terms and conditions of the Agreement dated October 17, 2017, shall remain in full force and effect.


