I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Landlord's Consent and Estoppel Certificate (Estoppel) confirming certain terms and conditions of the Development Site Lease Agreement with Palm Auto Plaza, LLC (Palm Auto) (R2014-0037, as amended) (Lease).

Summary: Palm Auto is obtaining a leasehold mortgage, and the lender, Toyota Motor Credit Corporation, requires the Estoppel to confirm certain terms and conditions of the Lease, including rental and that Palm Auto is not in default. <u>Countywide</u> (HF)
