The County has expended or encumbered \$33,802 (\$2,817/month) during the previous twelve (12) months of the current twelve (12) month term contract. A twelve (12) month extension to the current contract is necessary due to on-going labor negotiations and to provide sufficient time to prepare, evaluate and award a new contract once negotiations have concluded without a lapse in service. In addition, an increase of \$75,000, over the previously authorized amount of \$75,000, is required in order to provide labor negotiations during the contract extension. The original amount of the contract was \$100,000 for a period of twenty-four (24) months. This term contract has no renewal options. Awardee is located outside Palm Beach County in the City of Coral Gables, Florida. This contract was established by a competitive RFP process that allowed up to ten (10) points for SBE participation. No certified SBE participation was offered by the recommended awardee.
