Motion and Title: Staff recommends motion to approve: Work Authorization (WA) No. 11 to Hinterland Group, Inc., for the CD01 Water Distribution System Improvements Zones 2, 3 and 4 (Project) in the amount of \$1,264,998.80.

Summary: On January 10, 2017, the Board of County Commissioners (BCC) approved the Water Utilities Department (WUD) Pipeline Continuing Construction Contract (Contract) with Hinterland Group, Inc., (R2017-0072). WA No. 11 provides for the construction of approximately 5,500 linear feet of water mains throughout the eastern portion of the WUD service area. The work undertaken as part of the Project will improve system capacity, improve hydraulic efficiencies, eliminate dead ends and decrease water retention time in the distribution system resulting in improved water quality. The Small Business Enterprise (SBE) participation goal established by the SBE Ordinance is 15% overall. The Contract with Hinterland Group, Inc. provides for SBE participation of 15%. WA No. 11 includes 100% overall SBE participation. The cumulative SBE participation to date including WA No. 11 is 100%. Hinterland Group, Inc., is a Palm Beach County company. This project is included in the WUD FY19 Budget. (WUD Project No. 15-013) <u>Districts 4, 5 & 6</u> (MJ)

Background and Justification: WUD has implemented an Infrastructure Improvement Program for continuing and improving water service to the community. Completion of the work provided for in WA No. 11 will increase system capacity and reliability in the eastern portion of WUD's water distribution system.

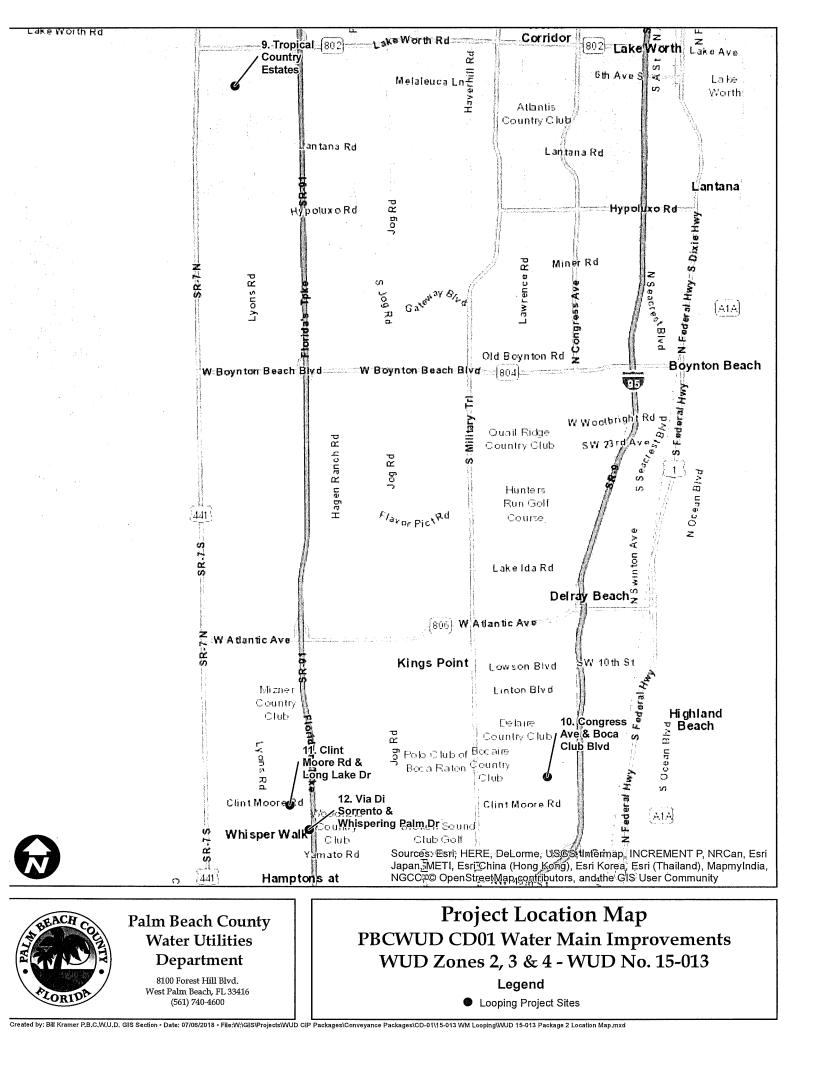

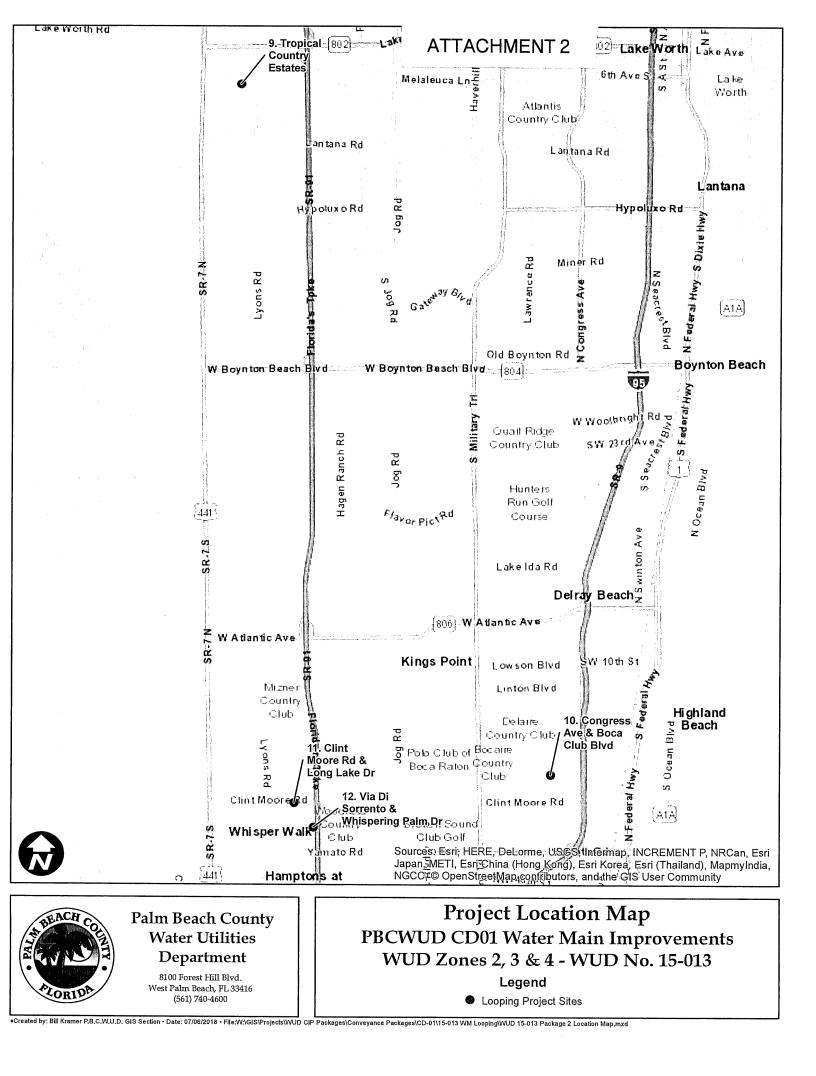
