### I. EXECUTIVE BRIEF

**Motion and Title:** Staff recommends motion to adopt: a Resolution of the Board of County Commissioners of Palm Beach County, Florida approving the Westgate/Belvedere Homes Community Redevelopment Agency's (CRA) Fiscal Year 2019 Budget for its Redevelopment Trust (operating) Fund and Capital Improvements Fund.

**Summary:** The Budget, in the amount of \$4,447,538, is composed of two (2) components. The first component, the Redevelopment Trust Fund, in the amount of \$3,208,538, consists of the CRA's Annual Tax Increment Financing (TIF) and balance brought forward from previous years. The second component, the Capital Improvement Fund, in the amount of \$1,239,000, consists of balances of reimbursable grants awarded to the CRA by County, State, and Federal governments for construction activities. The Tax Increment Financing revenues will be used for obligations to Florida Power & Light for street lighting, CRA operations and other projects. The 2019 Budget increased by twenty-nine percent (29%) because the CRA had an increase in TIF and grant funds. <u>Districts 2 and 7</u> (RB)

**Background and Justification:** Redevelopment Trust Fund: The FY 2019 Budget contains \$2,355,538 in anticipated TIF revenues. The budget contains salary and benefits for five (5) staff persons. The budget also contains funding for streetlights, property management, board and staff development, consultants, site development assistance program, special events, and other neighborhood improvement programs. In addition, the budget contains funding for two (2) new programs, Tenant Buildout Assistance and Rental Assistance Program.

<u>Capital Improvement Fund:</u> The FY 2019 Budget includes grants and balances of grants carried forward from prior years. Grant funds are anticipated to come from the Community Development Block Grant and Solid Waste Authority.
