





**Background and Justification: (Continued):**

The Cooperative Extension Department would continue to work with Facilities Development & Operations' Art in Public Places Administrator and Risk Management on all aspects of this exhibit. Patrick Dougherty is an internationally acclaimed artist who creates monumental scale environmental works. The sculpture at the Garden would be site-specific. The Friends intention is to offer this one-of-a-kind exhibit, which involves a Community Build experience with volunteers, in the beautiful setting of the Garden. Entering into a Standard License Agreement with the County would enable the Friends to execute a contract directly with the Artist and assume the responsibilities of being involved with the design, installation, and required insurance coverage. The final product, highlighting nature's beauty, will be the same as originally envisioned, and would reinforce the Garden's Artist in the Garden Master Plan. The Friends have been involved with Artists in two previous temporary Art exhibits in collaboration with Art in Public Places (Legos and Washed Ashore), in addition to working with Art in Public Places on the construction of the award-winning, Artist-designed Windows on the Floating World: Blume Tropical Wetland Garden. The Art in Public Places Administrator would still be engaged by the Friends for curatorial and programming purposes during the process of installing the *Stickwork* sculpture.


