I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

A) adopt a Resolution authorizing an extension to the term of the Concessionaire Service Agreement (Agreement) dated October 21, 2014 (R2014-1635), as amended, with Tennis Insights, Inc. (Tennis Insights), for the continued management and operation of the Tennis and Racquetball Center (Center) at Burt Aaronson South County Regional Park for a period of 30 days commencing on November 1, 2018, and continue on a month to month basis, if necessary, until terminated at a monthly rate of \$1,485.69 (\$17,828.29 annually); and

B) approve the Notice to Extend the Term of Agreement dated October 21, 2014 (R2014-1635), as amended.

Summary: Tennis Insights has managed and operated the Tennis and Racquetball Center (Center) at Burt Aaronson South County Regional Park under this current Agreement since October 2014. In May 2018, a Request for Proposals (RFP) was issued for tennis and racquetball concession services at the Park and staff is finalizing a concessionaire agreement with the selected respondent. The term of the Agreement expires on October 31, 2018. Rather than close the Center until a new concessionaire agreement is awarded, Tennis Insights has agreed to continue to operate and manage the Center until such time an award is made, at the same rent of \$1,485.69 per month. Staff believes it to be in the County's best interest to extend the Agreement for a period of 30 days so that staff can schedule the new concessionaire agreement for the November 20, 2018, Board meeting. This extension will extend the term of the Agreement for a period of 30 days commencing on November 1, 2018, and continue on a month to month basis, if necessary, to coincide with the approval of the new concessionaire agreement. The rent will remain at the current rate of \$17,828.29/year (\$1,485.69/monthly). County may terminate the Agreement at any time upon 15 days notice to Concessionaire. All other terms and conditions of the Agreement shall remain in full force and effect. Parks will continue to have administrative responsibility for this Agreement. (PREM) District 5 (HJF)

Background and Policy Issues: On October 21, 2014, the Board approved the Agreement with Tennis Insights. The initial term was November 1, 2014 through October 31, 2017. The Agreement required that Tennis Insights spend of a minimum of \$150,000.00 in improvements to the licensed area during the initial term in order to exercise its option to extend, which Tennis Insights had not expended. Rather than terminate the Agreement, Parks recommended that Tennis Insights be allowed to continue operations for an additional year so that a new RFP could be prepared.



Background and Policy Issues Cont'd: On October 17, 2017, the Board approved the First Amendment to Concessionaire Agreement (R2017-1588) which extended the term of the Agreement for one (1) year until October 31, 2018, with no renewal extension options, to allow time for staff to pursue options for the continued management and operation of the Center. In May 2018, an RFP was issued and staff is finalizing a concessionaire agreement with the selected respondent. Rather than close the Center until a new concessionaire agreement is awarded, Parks has requested Tennis Insights to continue to operate and manage the Center until an award is made. The new concessionaire agreement is anticipated to be presented to the Board for approval at the November 20, 2018, meeting. Rent will remain at the current rate of \$1,485.69 per month.

State Statutes do not require a Disclosure of Beneficial Interests be obtained when the County leases property to a tenant; however, Tennis Insights provided a Disclosure of Beneficial Interests in 2014 and has informed staff that no changes have occurred. Peter Davis, President, continues to hold a 100% beneficial interest in Tennis Insights, Inc.

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, AUTHORIZING AN EXTENSION TO THE TERM OF THE CONCESSIONAIRE SERVICE AGREEMENT WITH TENNIS INSIGHTS, INC., A FLORIDA CORPORATION, AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Tennis Insights, Inc., (Concessionaire), pursuant to a Concessionaire Service Agreement dated October 21, 2014 (R2014-1635), as amended, manages and operates the Tennis and Racquetball Center (Center) at Burt Aaronson South County Regional Park; and

WHEREAS, the Term of the Agreement as extended by the First Amendment to the Agreement dated October 17, 2017 (R-2017-1588), expires on October 31, 2018, with no renewal extension options to allow time for staff to pursue options for the continued management and operation of the Center, and

WHEREAS, in May 2018, a Request for Proposals was issued for tennis and racquetball concession services at the Park and staff is finalizing a concessionaire agreement with the selected respondent. It was anticipated that the new concessionaire agreement would be awarded before the expiration of the existing Concessionaire Service Agreement; and

WHEREAS, rather than close the Center until a new concessionaire agreement is awarded, the Concessionaire has agreed to continue to operate and manage the Center until such time an award is made at the same rent of \$1,485.69 per month; and

WHEREAS, the Concessionaire provides a service for the benefit of the public and the County wishes to retain the Concessionaire's operations at the Center until such time as a new concessionaire agreement is awarded; and

WHEREAS, the Board of County Commissioners of Palm Beach County hereby finds that the extension to the Term of the Concessionaire Service Agreement is in the best interest of the County as this extension to the Concessionaire Service Agreement with Tennis Insights, Inc. will ensure continued concession operations at the Center.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1. Recitals

The foregoing recitals are true and correct and incorporated herein by reference.

Section 2. <u>Authorization to Extend the Term of the Lease</u>

The Board of County Commissioners of Palm Beach County shall extend the Term of Concessionaire Service Agreement pursuant to the Notice to Extend Term of Concessionaire Service Agreement (R2014-1635), dated October 16, 2018, attached hereto and incorporated herein by reference, at a Guaranteed Annual Rent of \$17,828.29 (\$1,485.69 per month) as established by the First Amendment to Concessionaire Service Agreement.

Section 3. <u>Conflict with Federal or State Law or County Charter.</u>

Any statutory or Charter provisions in conflict with this Resolution shall prevail.

Section 4. <u>Effective Date.</u>
