I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: The establishment of the 2020 Census Complete Count Committee.

Summary: The 2020 Census Complete Count Committee (CCC) will be comprised of governmental and community leaders and organizations to increase awareness and motivate residents to respond to the 2020 Census. CCCs serve as "census ambassador" groups that play an integral part in ensuring a complete and accurate count of the community in the 2020 Census. Proposed committee representatives are:

County League of Cities Education (School District, all colleges and universities) Faith-Based organizations Media (particularly non-English) Community-Based organizations (League of Women Voters, HOAs, United Way, non-profit organizations) Businesses (Economic Council and Chambers) CareerSource

Background and Justification (or Policy Issues): April 1, 2020 is Census Day. The U.S. Census Bureau's official goal is to ensure that "everyone is counted once, only once and in the right place." Mandated by the U.S. Constitution and conducted every 10 years since the first one in 1790, the census will seek in 2020 to accurately count some 140 million households and over 325 million people. <u>Countywide</u> (DW)
