Motion and Title: Staff recommends motion to adopt: a Resolution of the Board of County Commissioners, Palm Beach County, Florida Repealing and Replacing Resolution No. R2014-1097; Expanding the uses of Victims of Crime Emergency Support Fund.

Summary: Palm Beach County Victims of Crime Emergency Support Fund (the "Victim Fund"), is funded by private donations, lawfully mandated fines and penalties and revenue received from a DUI Diversion Program operated by the Office of the State Attorney. The purpose of the fund is for providing emergency financial assistance to victims of crime, surviving family members and their families, staff training and development and awareness/recognition events. The fund currently has a balance of \$543,866 and increases by approximately \$100,000 each year. Additionally, the average amount expended per fiscal year is \$25,000 due to limitations set forth in the current resolution. It is being requested to expand the use of the "Victim Fund" per fiscal year as follows: 1) Increase funds from \$0 to \$40,000 to support a Violent Crimes Rape Crisis Helpline that is answered by trained counselors on a 24-hour basis to provide active listening and supportive counseling to victims of violent crime who are in crisis. A grant previously funded a portion of the Helpline; however that grant no longer allocates funding for the Helpline; 2) Increase funds from \$5,000 to \$40,000 for professional development to allow additional staff to attend conferences and trainings to maintain certifications that are a requirement of their job and to purchase educational and training equipment/materials and to purchase equipment and supplies for use at the sexual assault forensic exam site(s); and 3) Increase funds from \$5,000 to \$15,000, for events/awareness to allow for advertising through bus shelters, billboards, radio spots and public service announcements to promote services for victims of violent crime. <u>Countywide</u> (LDC)

Background and Policy Issues: The Board of County Commissioners established the Palm Beach County Victims of Crime Emergency Support on February 6, 1988, via Resolution No. R88-267 as a means to assist victims of crime in Palm Beach County. The "Victim Fund" was supported with private donations and court ordered contributions from domestic batterers and others. On or about 1996, the Court modified policies to preclude batterers court ordered fines as a condition of a plea or probation, which was a loss of revenue to the Victim fund. In December 2003, R88-267 was amended changing the name of the Victim Fund to "Victims of Crime Emergency Support Fund", included ad valorem support in the amount of \$35,000 to make up for the loss in revenue and deleted the support of indirect activities such as staff training and awareness activities, enabling the funds to be devoted to direct emergency relief of crime victims and their families. On July 22, 2014, R2014-1097 was amended to recognize revenue received from the Office of State Attorney DUI diversion program and reinstate staff training and development and awareness/recognition events. **Attachments**

RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA; REESTABLISHING THE VICTIMS OF CRIME EMERGENCY SUPPORT FUND; AUTHORIZING EXPENDITURES; PROVIDING FOR DISBURSEMENT; REPEALING AND REPLACING RESOLUTION NO. R-2014-1097.

WHEREAS, the Victims of Crime Emergency Support Fund (the "Victim Fund") was established originally in 1988 and most recently reestablished by Resolution R-2014-1097; and

WHEREAS, the Victim Fund is financed through a variety of sources including private donations, fines and penalties as established by the judicial system, diversion programs operated by the Office of the State Attorney, and ad valorem tax support (if appropriated) by the Board of County Commissioners; and

WHEREAS, the Victim Fund is primarily utilized to provide direct emergency financial assistance to victims of crime, their families and surviving family members in Palm Beach County for such things as food, clothing, temporary housing or shelter, utility payments, counseling and emergency medical services, that are directly related to the crime; and

WHEREAS, the Victim Fund is also used for staff professional development, awareness events, advertising and materials to promote services to victims of crime and volunteer/professional recognition events; and

WHEREAS, the growth of the Victim Fund allows for expanded use of the fund; and.

WHEREAS, continuing the Victim Fund is in the best interest of the County and the needs of victims of crime in Palm Beach County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY FLORIDA, that:

1. The Victim Fund is reestablished and will continue to be financed through private donations, fines and penalties as established by the judicial system and ad-valorem tax support if appropriated by the Board of County Commissioners.

2. The Palm Beach County Department of Public Safety, Division of Victim Services is responsible for administration of the Fund.

3. The Division of Victim Services will establish policies and procedures for the disbursement of money from the Fund by direct payment from the account and/or through a reimbursable checking account and associated petty cash accounts.

4. The Victim Fund will provide emergency financial assistance to victims of crime, their families and their surviving family members.

5. A maximum of \$40,000 of "The Victim Fund" will also support Violent Crimes Rape Crisis Helpline that is answered by trained counselors on a 24-hour basis to provide active listening and supportive counseling to victims of violent crime who are in crisis.

6. A maximum of \$40,000 annually of the Victim Fund may be utilized to assist Victim Services staff to develop professionally through attendance at seminars, training programs and conferences; purchase of educational and training equipment and materials for clients and staff, the purchase of equipment and supplies for use at the sexual assault forensic exam site(s) and sponsorship of workshops/retreats by the Division of Victim Services.

7. A maximum of \$15,000 of the Victim Fund may be used annually during nationally recognized Victim Awareness events (for example: Victims' Rights Week, Domestic Violence Awareness Month, Sexual Assault Awareness month) in order to make the public aware of our services and recognize volunteers and professional who provide assistance to victims of crime. These expenses may include, but not be limited to advertising campaigns through bus shelters, billboards, radio spots, Public Service Announcements and speaker fees.

8 Disbursement from the Victim Fund shall be by direct payment of use of check written on a reimbursable checking account or through the purchasing card procedure:

A. Checks will be written at the discretion of the Victim Services Division Director, Public Safety Department Director, Public Safety Director of Finance or Assistant County Administrator.

B. Checks written for \$500.00 or more will require approval of the Public Safety Department Director.

C. Checks written for \$1,000.00 or more will require approval of an Assistant County Administrator.

D. Disbursement of more than \$2,000.00 for any one person or incident will require approval of the Board of County Commissioners of Palm Beach County.

E. Reimbursement to the checking account shall be made by the Finance Department upon presentation of copies of cancelled checks.

F. Petty cash accounts, not to exceed \$300.00 each, may be established for individual operating teams in the Division of Victim Services with the approval of the Department Director.

10. Resolution No. R-2014-1097 is hereby repealed and replaced with this Resolution.

I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: A Resolution of the Board of County Commissioners, Palm Beach County, Florida Repealing and Replacing Resolution No. R-2003-2066; Amending the Funding Sources and Expanding the Uses of Victims of Crime Emergency Support Fund.

Summary: Palm Beach County Victims of Crime Emergency Support Fund (the "Victim Fund"), has historically been financed from numerous sources, including, private donations and lawfully mandated fines and penalties. In 2003, ad valorem tax support was added as an additional revenue source, however due to the economic downturn, the ad valorem support ended in 2008. In 2013, a new diversion program operated by the Office of the State Attorney for Driving Under the Influence (DUI) offenders reinstated a revenue stream to the Victim Fund. While the primary purpose of the fund is for emergency financial assistance to victims of crime, surviving family members and their families, reinstatement of prior use of the fund to include staff training and development and awareness/recognition events is being requested. <u>Countywide (PGE)</u>

Background and Policy Issues: The Board of County Commissioners established the Palm Beach County Victims of Crime Emergency Support on February 6, 1988 via Resolution No. R-88-267 as a means to assist victims of crime in Palm Beach County. The Victim Fund was supported with private donations and court ordered contributions from domestic batterers and others, but in about 1996, the Court modified policies for fees and fines related to probation, which resulted in a loss of revenue to the Victim Fund. In December 2003, R-88-267 was amended, which changed the name of the fund to "Victims of Crime Emergency Support Fund," included an ad valorem support in the amount of \$35,000.00 per year to make up for the loss in revenue, and deleted the support of indirect activities such as staff training, development, and awareness activities, enabling the funds to be devoted to direct emergency relief of crime victims and their families.

WHEREAS, the current Palm Beach County Victims of Crime Emergency Support Fund (the "Victim Fund") has historically been financed from numerous sources, including, private donations, ad valorem tax support (if appropriated) by the Board of County Commissioners, and various fines and penalties as established by the judicial system; and

WHEREAS, the Victim Fund is primarily utilized to provide direct emergency financial assistance to victims of crime, their families and surviving family members in Palm Beach County for such things as food, clothing, temporary housing or shelter, utility payments, counseling, etc., that are directly related to the crime, as well as for staff professional development, awareness events and materials and volunteer/professional recognition events; and

WHEREAS, expenditures for the victims of crime, families of the victims, and staff working with the victims and their families, have always been dependent on the stream of revenue into the Victim Fund, requiring at times, the curtailment of previously approved expenditures, particularly staff training, development and awareness/recognition events, from the Victim Fund; and

WHEREAS, a new diversion program operated by the Office of the State Attorney for Driving Under the Influence (DUI) offenders was reinstated in 2013, resulting in additional fees to increase the revenue stream for the Victim Fund, making it feasible to once again fund staff trainings, professional development, purchase of education and training equipment for clients and staff, and awareness/recognition events; and

WHEREAS, amending the funding sources and expanding the uses for the Victim Fund is in the best interest of the County and the needs of victims of crime in Palm Beach County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISIONERS OF PALM BEACH COUNTY FLORIDA, that:

1. The Victims of Crime Emergency Support Fund will continue to be financed through private donations, ad-valorem tax support (if appropriated) by the Board of County Commissioners, and fines and penalties as established by the judicial system, including, but not limited, to the new DUI diversion program operated by the Office of the State Attorney.

2. The Palm Beach County Department of Public Safety, Division of Victim Services ("Division of Victim Services") is responsible for administration of the Victims of Crime Emergency Support Fund.

I. EXECUTIVE BRIEF

Motion and Title: Staff recommends a motion to adopt: A Resolution of the Board of County Commissioners, Palm Beach County, Florida changing the title of the Victims' Fund, amending the primary uses of the Palm Beach County Victims Fund, and rescinding Resolution No. R-99-292.

Summary: From 1988 to approximately 1996, the Palm Beach County Victims' Fund was funded by private donations and lawfully mandated fines and penalties. Due to various changes of the Courts and defense attorneys, contributions to the County's Victims' Fund as a condition of a defendant's plea were discontinued and the fund was slowly depleted. Staff presented, and the Board approved, a supplemental request to support the fund with \$35,000 of ad valorem taxes during FY04. This resolution continues the Fund and renames it the "Victims of Crime Emergency Support Fund" and provides for emergency financial assistance to victims of violent crime, their families, and surviving family members who suffer as a direct result of the crime. With limited contributions, deleting the support of indirect activities such as staff training and education and activities related to Victim's Rights Week will enable the funds to be devoted to the direct emergency relief of crime victims and their families.

Background and Justification: The Board of County Commissioners established the Palm Beach County Victims' Fund on February 6, 1988 via Resolution No. R-88-267 as a means to assist victims of crime in Palm Beach County. The fund was supported with private donations and court ordered contributions from domestic batterers and others. On or about 1996, the Court modified policies and procedures to preclude court ordered contributions to the Victims' Fund as a condition of a plea or probation. As a result, lawfully mandated fines and penalties no longer support the fund. Donations and other 'non-tax' funding have been minimal and are insufficient to adequately support the needs of the victims. The Fund provides, as examples, emergency rent, mortgage, utility payments, emergency sheltering, food vouchers, emergency medications, etc.

WHEREAS, the Victims Fund is also used to provide assistance to the surviving family members of crime victims, and to facilitate counseling to victims and their family members; and

WHEREAS, continuing the Victims Fund with ad-valorem tax support in addition to whatever private donations and mandated fines and penalties are generated is in the best interest of the County and the needs of victims of crime in Palm Beach County.

3. The Division of Victim Services will establish policies and procedures for the disbursement of money from the Fund by direct payment from the account and/or though a reimbursable checking account and associated petty cash accounts.

4. The primary use of the Victims Fund will be to provide emergency financial assistance to victims of crime, their families and their surviving family members.

5. Disbursement from the Fund shall be by direct payment or use of check written on a reimbursable checking account:

- A. Checks will be written at the discretion of the Victim Service Division Director, Public Safety Department Director, or Assistant County Administrator.
- B. Checks written for \$500.00 or more will require the approval of the Public Safety Department Director.
- C. Checks written for \$1,000.00 or more will require approval of an Assistant County Administrator.
- D. Disbursement of more than \$2,000.00 for any one person or incident or activity requires approval of the Board of County Commissioners of Palm Beach County.
- E. Reimbursement to the checking account shall be made by the Finance Department upon presentation of copies of the canceled checks.
