#### I. EXECUTIVE BRIEF

**Motion and Title:** Staff recommends motion to: A) receive and file a fully executed Children's Services Council Grant Agreement for the Glades Family Fun Fest in the amount of \$2,500 for the period January 23, 2019, to April 23, 2019; and **B) approve** Budget Amendment of \$2,500 within the General Fund to establish budget for the approved grant.

**Summary:** The Parks and Recreation Department submitted an electronic grant application on October 4, 2018, to the Children's Services Council of Palm Beach County. The Department was awarded the grant and the grant agreement was executed by the Director of Parks and Recreation on behalf of the Board of County Commissioners pursuant to PPM CW-F-003. The grant funding will be utilized to enhance the 4<sup>th</sup> Annual Glades Family Fun Fest community event taking place in Belle Glade. The County was awarded grant funding which will support and educate the residents of Pahokee, Belle Glade and South Bay of the many benefits offered through local agencies in the area and to promote health and wellness through a variety of games and activities. The Glades Family Fun Fest is a free event for all ages and residents of western Palm Beach County. The collaboration helps align both organization's missions and reinforces the importance of children growing up healthy, safe and strong. The estimated number of attendees is between 500 – 600. The grant does not require a County match. District 6 (AH)

Background and Justification: The Children's Services Council of Palm Beach County provides leadership, funding, services and research on behalf of Palm Beach County's children so they grow up healthy, safe and strong. The Parks and Recreation Department's mission is to make the quality of life for Palm Beach County residents and visitors better by providing diverse, safe and affordable recreation services, welcoming parks, and enriching social and cultural experiences. The Parks and Recreation Department achieves this by planning and implementing community events that promote wellness, which improves our community for this, and future generations. The County was awarded grant funding which will support and educate the residents of Pahokee, Belle Glade and South Bay of the many benefits offered through local agencies in the area and to promote health and wellness through a variety of games and activities. The Glades Family Fun Fest is a free event for all ages and residents of western Palm Beach County. The collaboration helps align both organization's missions and reinforces the importance of children growing up healthy, safe and strong.

#### **GRANT AGREEMENT FOR HEALTHY, SAFE AND STRONG FUNDS**

THIS AGREEMENT made as of February (2,2019, by and between the Children's Services Council of Palm Beach County, an independent special district under the laws of the State of Florida, hereinafter designated as the "CSC", and Palm Beach County by and through its Board of County Commissioners hereinafter referred to as "Provider", effective January 23, 2019 ("Effective Date") to April 23, 2019.

#### WITNESSETH:

IN CONSIDERATION of mutual agreements hereinafter contained, the parties intending to be legally bound hereby agree as follows:

The CSC agrees to reimburse PROVIDER in accordance with the following schedule and terms for services to be provided as outlined in the attached Exhibit "A".

- 1. Transfers from the CSC to the Provider will be made in accordance with the following procedures:
  - a. The CSC agrees to reimburse Provider an amount not to exceed \$2,500 for support for Glades Family Fun Fest as described in **Exhibit "A"** and **Exhibit "B"** attached hereto and made a part hereof.
  - b. No transfers will be made by the CSC pursuant to this Agreement after April 23, 2019.
  - c. A Request for Reimbursement of Healthy, Safe and Strong Fund, **Exhibit "B"** will be provided to CSC no later than March 26, 2019.
- 2. **CSC Logo Guidelines:** To ensure consistent brand messaging, the provider will use the CSC's logo in print materials, signage and relevant event messaging. This can include website logo placement, press releases and social media. Use the horizontal logo only in instances where there is minimal vertical space and the primary stacked logo will not fit properly. Please visit: <a href="https://www.cscpbc.org/logos">www.cscpbc.org/logos</a> for guidelines. If you have further questions, please call 561-740-7000, extension 2208.
- 3. The Provider agrees to retain all financial records, supporting documents, statistical records and any other documents pertinent to this Agreement for a period of six (6) years following termination of this Agreement or, if an audit has been initiated and audit findings have not been resolved at the end of the six year period, the records shall be retained until resolution of all audit findings. Provider further agrees that all records, papers, letters, or other documents made or received in conjunction with this Agreement and the provision of services hereunder shall be subject to public access pursuant to the provisions of Chapter 119, Florida Statutes. The provisions of this paragraph shall survive termination of this Agreement.
- 4. Inspector General Palm Beach County has established the Office of the Inspector General in Palm Beach County Code, Section 2-421-2-440, as may be amended. The Inspector General's authority includes but is not limited to the power to review past, present and proposed County contracts, transactions, accounts and records, to require the production of records, and to audit, investigate, monitor, and inspect the activities of the CSC, its officers, agents, employees and lobbyists in order to ensure compliance with contract requirements and detect corruption and fraud. Failure to cooperate with

the Inspector General or interfering with or impeding any investigation shall be in violation of Palm Beach County Code, Section 2-421-2-440, and punished pursuant to Section 125.69, Florida Statutes, in the same manner as a second degree misdemeanor.

- 5. No Agency Relationship Neither party is an agent or servant of the other. No person employed by either party to this Agreement, shall in connection with the performance of this Agreement or any services or functions contemplated hereunder, at any time, be considered the employee of the other party, nor shall an employee claim any right in or entitlement to any pension, worker's compensation benefit, unemployment compensation, civil service, or other employee rights or privileges granted by operation of law or otherwise, except through and against the party by whom they are employed.
- 6. Severability In the event that any section, paragraph, sentence, clause, or provision of this Agreement is held by a court of competent jurisdiction to be invalid, such shall not affect the remaining portions of this Agreement and the same shall remain in full force and effect.
- 7. Non-discrimination CSC warrants and represents that all of its employees are treated equally during employment without regard to race, color, religion, disability, sex, national origin, age, ancestry, marital status, familial status, sexual orientation, gender identity and expression, or genetic information.
- 8. Remedies This Agreement shall be governed by the laws of the State of Florida. Any legal action necessary to enforce this Agreement will be held in a court of competent jurisdiction located in Palm Beach County, Florida. No remedy conferred upon any party is intended to be exclusive of any other remedy and each and every such remedy shall be cumulative and shall be in addition to every other remedy given hereunder or hereafter existing at law or in equity, by statute or otherwise. No single or partial exercise by any party of any right, power, or remedy hereunder shall preclude any other or further exercise thereof. No provision of this Agreement is intended to, or shall be construed to create any third party beneficiary or to provide any rights to any person or entity not a party to this Agreement, including but not limited to any citizen or employees of the Provider and/or CSC.
- 9. All notices required in this Agreement shall be sent certified mail, return receipt requested, hand delivery or other delivery service requiring signed acceptance.
