## I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Amendment No. 2 to the Water Utilities Department (WUD) Consulting/Professional Services Surveying and Mapping Services (Contract) with Dennis J. Leavy & Associates, Inc., renewing the Contract for an additional one (1) year period.

**Summary:** On June 6, 2017, the Board of County Commissioners (BCC) approved the WUD Consulting/Professional Services Surveying and Mapping Services (Contract) with Dennis J. Leavy & Associates, Inc., (R2017-0732). The Contract provides Surveying and Mapping Services for utility related projects and will be available for utilization by other County Departments. The Contract included a 12-month term with the option of two (2) 12-month renewals at the discretion of the County.

Amendment No. 1 to the Contract renewed the Contract for one (1) year through June 5, 2019 with no cost increase to the Contract.

Amendment No. 2 to the Contract constitutes one (1) year Contract renewal through June 4, 2020, with no cost increase to the Contract and is to provide additional professional consultation/surveying and mapping services throughout WUD service area.

This Contract was procured under the requirements of the 2002 Small Business Enterprise (SBE) Ordinance (R2002-0064) prior to the adoption of the amended Equal Business Ordinance on October 16, 2018. The Small Business Enterprise (SBE) participation goal established by the 2002 SBE Ordinance under which this Project was solicited is 15% overall. WUD staff coordinated with the Office of Equal Business Opportunity to confirm that the proposed renewal was consistent with the principles of the Equal Business Opportunity Ordinance. The Contract with Dennis J Leavy & Associates, Inc., provides for 100% overall SBE participation. Dennis J. Leavy & Associates, Inc., is a Palm Beach County company. (WUD Project No. 16-082) Countywide (MJ).

**Background and Justification:** The ongoing operation, maintenance and administration of the WUD and other Palm Beach County Departments require surveying and mapping services to supplement staff availability and expertise. The Contract will be utilized to provide these services for utility related projects. Amendment No. 2 will provide an additional one (1) year to the Contract with no more renewal options remaining. The term and conditions of the Contract will remain in full force and effect.

WHEREAS the parties hereto desire to renew the Contract for an additional one (1) year period; and


