#### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Work Authorization (WA) No. 3 to the Contract for Optimization and Improvements Design-Build with Globaltech, Inc., for the Water Treatment Plant (WTP) No. 8 Anion Exchange Rehabilitation and Cleaning (Project) in the amount of \$1,239,354.21.

Summary: On January 15, 2019, the Board of County Commissioners (BCC) approved the Water Utilities Department (WUD) Contract for Optimization and Improvements Design-Build (R2019-0099) with Globaltech, Inc. WA No. 3 provides for the replacement of piping and valves in the Anion Exchange (AIX) treatment process vessels 1 to 7, implementation of caustic cleaning of resin in AIX vessels 1 to 21, installation of safety improvements for AIX vessels 1 to 21 and replacement of two (2) high service pump bay rollup doors with hurricane resistant rollup doors. This Contract was procured under the requirements of the 2002 Small Business Enterprise (SBE) Ordinance (R2002-0064) prior to the adoption of the amended Equal Business Opportunity Ordinance on October 16, 2018. The SBE participation goal established under the 2002 Ordinance was 15% overall participation. The Contract provides for 58% SBE participation which includes 12% MWBE participation, 10% MWBE (H), 1% MWBE (B) and 1% WA No. 3 includes 96.82% SBE, 2.68% MBE (H) and 0.48% MBE (O) participation. The cumulative SBE and M/WBE participation including WA No. 3 is 92.40% SBE, 0.37 MBE (B), 4.49% MBE (H) and 2.73% MBE (O) participation. Globaltech, Inc., is a Palm Beach County company. The Project is included in WUD's FY19 budget. (WUD Project No. 19-039) <u>District 2</u> (MJ)

**Background and Justification:** The existing AIX vessels 1 to 7 have been in operation since 2008. The brine header piping and valves are showing signs of deterioration and require replacement. The water treatment resin in AIX vessels 1 to 21 needs to be caustic cleaned to enhance total organic carbon removal and maintain the resin warranty. Safety improvements for AIX vessels 1 to 21 will be constructed to add a safe tie-off when Operations and Maintenance personnel transfers from the catwalk to an AIX vessel for access. The two (2) existing high service pump bay rollup doors need to be replaced with hurricane resistant rollup doors to enhance building safety during a hurricane event.
