I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to: A) adopt a Resolution repealing Resolution R81-914, which will rescind the Boynton Beach Municipal Golf Course Advisory Committee operating statement; and **B) approve** Amendment No. 1 to the lease agreement R90-871D, between Palm Beach County and the City of Boynton Beach deleting the requirement to establish the Boynton Beach Municipal Golf Course Advisory Committee.

Summary: On February 12, 1980, Palm Beach County executed a lease agreement for approximately 150 acres of land on Jog Road with the City of Boynton Beach for the development of a municipal golf course. Within the lease agreement, the parties agreed to establish a five member advisory committee comprised of three City of Boynton Beach appointees and two Palm Beach County appointees. The committee was tasked with providing advice to the City on planning, construction, maintenance, and operation of the golf course. The golf course has been operating for over 30 years and the advisory committee has not conducted official business since 2015. The municipal golf course development project has been complete for many years and the City of Boynton Beach has a professional golf operations and maintenance staff that are experienced in the operation of golf facilities. As a result, the City no longer requires the services of a citizen advisory committee. <u>District 3 (AH)</u>

Background and Justification: On February 12, 1980, Palm Beach County executed a lease agreement for approximately 150 acres of land on Jog Road with the City of Boynton Beach for the development of a municipal golf course. Within the lease agreement, the parties agreed to establish a five member advisory committee comprised of three City of Boynton Beach appointees and two Palm Beach County appointees. The committee was tasked with providing advice to the City on planning, construction, maintenance, and operation of the golf course. The golf course has been operating for over 30 years and the advisory committee has not conducted official business since 2015. WHEREAS, the Board of County Commissioners adopted the Boynton Beach Municipal Golf Course Advisory Committee operating statement on July 21, 1981 Resolution R81-914; and

WHEREAS, the City of Boynton Beach no longer require the services of the Advisory Board; and

WHEREAS, the Board of County Commissioners of Palm Beach County desires to repeal Resolution R81-914; and

WHEREAS, repealing Resolution R81-914 and dissolving the Advisory Committee serves a public purpose.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, that:

Section 1: Recitals

Section 2: Repeal
