I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Consultant Services Authorization (CSA) No. 11 for Loxahatchee River Restoration Local Initiative and Mecca Site Evaluation with Kimley-Horn and Associates, Inc., (Consultant) for a fixed price amount of \$199,956.

Summary: On July 11, 2017, the Board of County Commissioners (BCC) approved the Water Utilities Department Contract for Consulting/Professional Services for Water Treatment and Water Resources Engineering Services (Contract) (R2017-0903) with Consultant. CSA No. 11 provides for professional engineering services to prepare technical information on the feasibility of additional alternatives that address County concerns with the U.S. Army Corps of Engineers' (USACE) Loxahatchee River Watershed Restoration Project (Loxahatchee Project), specifically the deep storage reservoir proposed for the Mecca site. This Contract was procured under the requirements of the 2002 Small Business Enterprise (SBE) Ordinance (R2002-0064) prior to the adoption of the amended Equal Business Opportunity Ordinance on October 16, 2018. The SBE participation goal established under the 2002 Ordinance was 15% overall participation. The Contract provides for 28% SBE participation and 7% Minority/Women Business Enterprise (M/WBE) participation. CSA No. 11 includes 0% SBE and 0% M/WBE participation. The cumulative SBE and M/WBE participation is 20.90% SBE and 1.73% M/WBE. Kimley-Horn and Associates, Inc., is headquartered in Raleigh, North Carolina but maintains an office in Palm Beach County from which the majority of the work under CSA No. 11 will be undertaken. (WUD Project No. 19-060) Districts 1, 2 and 6 (MJ)

Background and Justification: At the BCC workshop meeting held April 30, 2019, County staff briefed the BCC on USACE's proposed Loxahatchee Project. After hearing numerous public comments and a robust discussion, the BCC directed staff to communicate key concerns with the project and express interest in collaborating with the USACE and South Florida Water Management District (SFWMD) to reconsider the Mecca Reservoir to be more compatible with adjacent lands. The BCC also supported staff's desire for the County to be in a stronger leadership position with regard to the development of locally preferred water resources projects and supported staff's recommendation to hire technical consultants in an effort to optimize or improve the Loxahatchee Project. This evaluation will identify and assess additional alternatives and provide technical information necessary to enable continued collaboration with USACE and SFWMD and provide tools that can be used for future County water resources planning and management activities in the region.

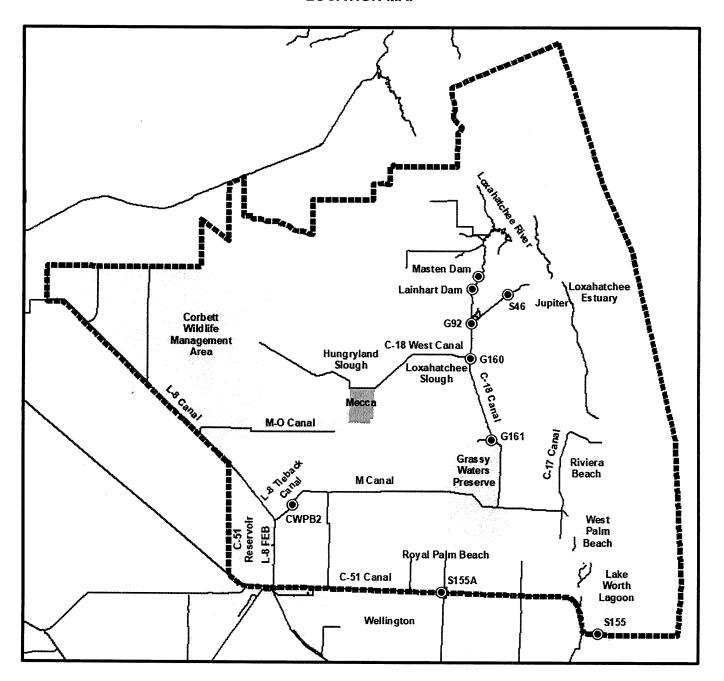

CONSULTANT shall perform:

The following scope includes the preparation of technical information on the feasibility of additional alternatives that address County concerns with the U.S Army Corps of Engineers' Loxahatchee River Watershed Restoration Project, specifically the deep water storage reservoir proposed for the Mecca site.

SCOPE OF SERVICES

1.0 INTRODUCTION AND BACKGROUND

At the Palm Beach County Board of County Commissioners (BCC) workshop meeting held April 30, 2019, County staff briefed the BCC on the Draft Integrated Project Implementation Report (PIR) and Environmental Impact Statement (EIS) for the Loxahatchee River Watershed Restoration Project (Loxahatchee Project or LRWRP) and requested direction regarding the development and submittal of comments on the Draft PIR/EIS. After hearing numerous public comments from stakeholders and a robust discussion, the BCC directed staff to communicate key concerns with the project and express interest in collaborating with the U.S. Army Corps of Engineers (USACE) and the South Florida Water Management District (SFWMD) to reconsider the Mecca Reservoir to be more compatible with adjacent lands.

In addition, the BCC supported staff's desire for the County to be in a stronger leadership position with regard to the development of locally preferred water resources projects and supported staff's recommendation to hire technical consultants to assist with data collection, modeling and alternatives analysis in an effort to improve the proposed Loxahatchee Project.

In a May 2, 2019 letter, the SFWMD communicated their support of continued collaboration with key local stakeholders and the USACE related to compatibility of the Mecca storage reservoir with adjacent lands. In May 2019, County staff began coordinating with SFWMD and USACE to determine potential forward paths.

The Loxahatchee River Watershed Restoration Local Initiative Evaluation is a study intended to provide technical information on the feasibility of additional alternatives that specifically address County concerns with the Loxahatchee Project and attempt to improve it. The results of this study are intended to augment the technical work prepared by the USACE and SFWMD and documented in the Draft PIR/EIS dated March 2019.

The County is concerned that the Loxahatchee Project does not address excess stormwater runoff from the L-8 Basin. Without additional storage and a plan to re-direct L-8 basin stormwater, negative impacts to the Lake Worth Lagoon, which receive large volumes of L-8 basin stormwater runoff, will continue. In addition, achieving Everglades water quality requirements will be very challenging without additional storage.

There is also concern that the proposed 20-foot embankment height of the C-18 West (or Mecca) Reservoir is not compatible with adjacent lands, is not aesthetically appealing and introduces unnecessary risks to adjacent residents and existing County-owned Water Utilities Department infrastructure. For example, a re-pump station is located on the southeastern corner of the Mecca site and provides potable water service to the North Palm Beach County Airport and several large private customers. The County also currently owns approximately 98 acres of land located south and east of the proposed Mecca reservoir, which is currently under consideration for a future County roadway.

In addition, there is concern that the 70 percent recovery efficiency assumed for the proposed Aquifer Storage and Recovery (ASR) wells is optimistic and not supported by technical information included in the Draft PIR/EIS. In addition, there appears to be high uncertainty regarding the future achievement of water quality standards related to ASR well operations.

Poorly justified assumptions and high uncertainty result in many questions about the accuracy and robustness of the Draft PIR/EIS modeling results as well as the legitimacy of the Loxahatchee Project's tentatively selected plan (TSP).

The focus of this study is concentrated on developing and evaluating alternatives using the existing suite of management measures, components or options previously considered during the preparation of the Draft PIR/EIS. While some new concepts may be warranted, it is expected that the alternatives to be evaluated in this study will primarily consist of new combinations of management measures/components/options that have already been conceptualized, but were packaged in a way that resulted in a limited ability to detect the benefits of individual elements.

2.0 OBJECTIVES

This development and preparation of information during this study shall be consistent or compatible with the methodologies utilized in the Draft PIR/EIS for the Loxahatchee Project. The specific objectives of this study are as follows:

- 1. Review and evaluate existing information, studies, modeling and reports related to the Loxahatchee Project and project features proposed for the Mecca site,
- Develop alternatives that address County concerns with the proposed Loxahatchee Project,
- Develop and implement an approach to quickly screen and evaluate alternatives, utilizing SFWMD-developed methodologies or screening tools and/or the existing Loxahatchee Project modeling tools,
- 4. Recommend additional management measures/components/options that address County concerns with the proposed Loxahatchee Project (if warranted),
- 5. Prepare performance measures, habitat unit calculations, and cost estimates for highperforming alternatives, and
- 6. Summarize model-simulated flows from the L-8 Basin to the Lake Worth Lagoon (via the C-51 Canal) to enable simple comparisons between alternatives.

While there may be deficiencies with the Loxahatchee Project modeling tools, it is not the objective of this study to re-calibrate or re-validate the existing modeling tools. Instead, the intent is to provide additional results that are consistent and compatible with the existing modeling tools, performance measures and habitat units.

3.0 SCOPE OF WORK

All submittals shall consist of one (1) electronic copy and one (1) bound hard copy. All technical references used in completing the work shall be documented by the CONSULTANT. Depending on the deliverable, the CONSULTANT shall provide it in Microsoft (MS) Word, MS Excel, MS Access, AutoCAD, ArcGIS, or metadata format compatible with County software versions. The CONSULTANT shall provide reports in a completed format with all tables and figures included in the file of the report. Appendices can be provided as a separate file but all figures and tables within that appendix must be included in that same file. Additionally, the CONSULTANT shall provide full reports and figures as Adobe PDF files.

The CONSULTANT shall provide the project management and coordination for the activities performed under this Scope of Services. The CONSULTANT shall monitor labor utilization, project schedule, and project budget on a regular basis. It shall be the ongoing responsibility of the CONSULTANT Project Manager (CONSULTANT PM) to manage task budgets and schedules to meet milestones and deliverable due dates. The CONSULTANT PM shall be fully responsible for the performance of the CONSULTANT's team, including sub-consultants, for this Scope of Services. The CONSULTANT PM shall communicate with the PM on a weekly or other agreed upon basis and document the communication.

Task 1 – Project Kick-Off Meeting and Work Plan

Within one (1) week after the execution date of the Scope of Services, the CONSULTANT shall attend and facilitate a Kick-Off meeting in West Palm Beach, Florida. The objective of this meeting is to confirm the project objectives, review the statement of work and schedule, establish lines of communication for data sharing, review available data and reports, and clarify project requirements. The CONSULTANT is not required to provide a formal presentation at the meeting.

The CONSULTANT shall develop a detailed Draft Work Plan. The CONSULTANT will review existing relevant documents related to the Loxahatchee Project and previous Mecca-related evaluations conducted by SFWMD. The County will review the Draft Work Plan and provide comments to the CONSULTANT. The CONSULTANT shall address County comments and submit a Final Work Plan.

Task 1 Deliverables:

- **1.1** CONSULTANT shall attend and facilitate a Kick-Off Meeting with County staff and prepare and submit a **Kick-Off Meeting Summary**.
- 1.2 CONSULTANT shall prepare and submit a **Draft Work Plan**.
- **1.3** CONSULTANT shall prepare and submit a **Final Work Plan** incorporating input obtained from the County.

Task 2 - Alternative Development and Screening

An objective of this study is to collaborate with the County and incorporate stakeholder input to develop alternatives that address County concerns regarding the proposed Loxahatchee Project, specifically the Mecca reservoir embankment height and the desire to implement a project element on Mecca that is more compatible with adjacent lands, has less potential flood risk and is more aesthetically pleasing.

In collaboration with the County PM and based on a review of the alternatives previously considered by SFWMD during Mecca pre-acquisition modeling activities and during the Draft PIR/EIS, the CONSULTANT will develop an approach to formulate up to eight (8) alternatives and develop an efficient approach to screen alternatives to enable promotion of high-performing alternatives for further more detailed analysis. One screening approach that could be considered is the screening process implemented by SFWMD during their evaluation of L-8 Reservoir replacement storage options during their Restoration Strategies planning efforts that assisted in providing justification for SFWMD to purchase the Mecca site from Palm Beach County.

A goal of the alternative development and screening process is to meet or exceed performance measure targets and/or habitat units that were achieved by the TSP, as documented in the Draft PIR/EIS.

One screening approach that should be considered is to develop a river flow demand (daily or annual average volume) that can be used as a surrogate to identity the amount of storage needed to achieve river restoration performance measure targets.

Some examples of concepts and/or alternatives that could be considered during alternative development are as follows:

- 1. TSP (Alternative 5R) with no ASR wells
- 2. TSP (Alternative 5R) with ASR wells at 25-50 percent recovery efficiency
- 3. TSP (Alternative 5R) with no ASR wells and no reservoir; Mecca site is a shallow impoundment or flow-through marsh (2.5 to 4 feet maximum water depth)
- 4. Alternative 12 with Option 3-E (instead of with Option 3-B)
- 5. Shallow impoundment or flow-through marsh in the L-8 Basin (~1,700-acres), perhaps integrated with Indian Trail Improvement District's existing M1 impoundment (~720 acres)
- 6. Incorporate flows from Mecca to and through the proposed Avenir ~2,000-acre natural area
- 7. Capture and temporarily store excess L-8 Basin stormwater for delivery to the Loxahatchee River via the M-O and C-18 Canals

In addition, CONSULTANT shall present an overview of work products completed to date and facilitate a public workshop discussion at a Palm Beach County Water Resources Task Force Meeting (currently scheduled for July 25, 2019). The objective of the public workshop is to obtain additional input from stakeholders regarding desired management measures, components, or options to potentially be included in alternatives to be evaluated by the CONSULTANT.

Based on input from stakeholders and in collaboration with the County PM, CONSULTANT shall conduct an alternative screening evaluation to identify up to three (3) promoted alternatives with the highest potential to address County concerns and achieve project performance similar to the TSP.

Task 2 Deliverables:

- 2.1 CONSULTANT shall present at and facilitate a public workshop discussion at a Palm Beach County Water Resources Task Force Meeting (currently scheduled for July 25, 2019 at 1:30pm). CONSULTANT shall prepare and submit a **Draft Alternative Development and Screening Technical Memorandum** summarizing the information provided by stakeholders at the public workshop discussion, providing a recommended approach to incorporating this information into alternatives and summarizing the alternatives to be screened.
- **2.2** CONSULTANT shall prepare and submit a **Draft Alternative Screening Technical Memorandum** summarizing the screening approach, activities and results.

Task 3 – Alternative Simulation and Effectiveness Evaluation

CONSULTANT shall utilize the Lower East Coast Subregional Model - North Palm version (LECSR-NP) which was used by SFWMD/USACE for the Loxahatchee Project to simulate up to four (4) promoted alternatives identified in Task 2. While there may be deficiencies with LECSR-NP, it is not the objective of this study to re-calibrate or re-validate the model. This model will be provided to the CONSULTANT by the County for use during this study.

Task 3.1 - Alternative Simulation

Based on the results of Task 2 Screening Evaluation, the CONSULTANT shall prepare LECSR-NP simulations for up to three (3) promoted alternatives. CONSULTANT shall use professional judgement and scientific and engineering principles in applying LECSR-NP to enable the promoted alternatives to be appropriately simulated, evaluated and compared with alternatives previously evaluated by SFWMD/USACE during the Draft PIR/EIS and to enable performance measure development and habitat unit calculations consistent with the methodologies used in the Draft PIR/EIS.

CONSULTANT shall coordinate with SFWMD, USACE and County staff to gain consensus on the existing modeling approach so that proposed modifications to evaluate the County's alternatives are implemented correctly. This will allow the Loxahatchee Project alternatives to be appropriately compared and contrasted with the County's alternatives.

Due to County and stakeholder concerns, CONSULTANT shall prioritize the development and evaluation of the following alternative: TSP (Alternative 5R) with no ASR wells and no reservoir; Mecca site is a shallow impoundment or flow-through marsh (~2.5 to 4 feet maximum water depth). This approach is intended enable the early development of a river restoration flow demand deficit (daily or annual average volume) that can be used as a surrogate to identity additional storage, if needed, to achieve river restoration performance measure targets.

Task 3.1 Deliverable:

3.1.1 - CONSULTANT shall prepare a **Draft Alternative Evaluation Results Technical Memorandum** summarizing the results of Task 3.1 activities.

Task 3.2 Effectiveness Evaluation

The three (3) promoted alternative plans will be evaluated using the USACE's "Principles and Guidelines" criteria as described in Section 4 of the Loxahatchee Project Draft PIR/EIS. This task will focus on one (1) of the four (4) criteria, Effectiveness, which is the extent to which an alternative plan alleviates the specified problems and achieves the specified opportunities.

Effectiveness is to be evaluated using the same five objectives and approach as documented in Section 4.1 of the Draft PIR/EIS:

- Objective 1 Flows to the River
- Objective 2 Estuarine Communities
- Objective 3 Area of Wetlands
- Objective 4 Connectivity
- Objective 5 Plant and Animal Abundance and Diversity

Effectiveness index scores shall be calculated and presented for the three (3) promoted alternatives along with index scores that were documented for the Future Without (FWO) Project Condition and Alternative 5 in the Draft PIR/EIS.

Task 3.2 Deliverable:

3.2.1 - CONSULTANT shall prepare a Final Alternative Evaluation Results Technical Memorandum incorporating input and comments from the County PM on the Draft Alternative Evaluation Results Technical Memorandum and summarizing the results of the Task 3.2 activities.

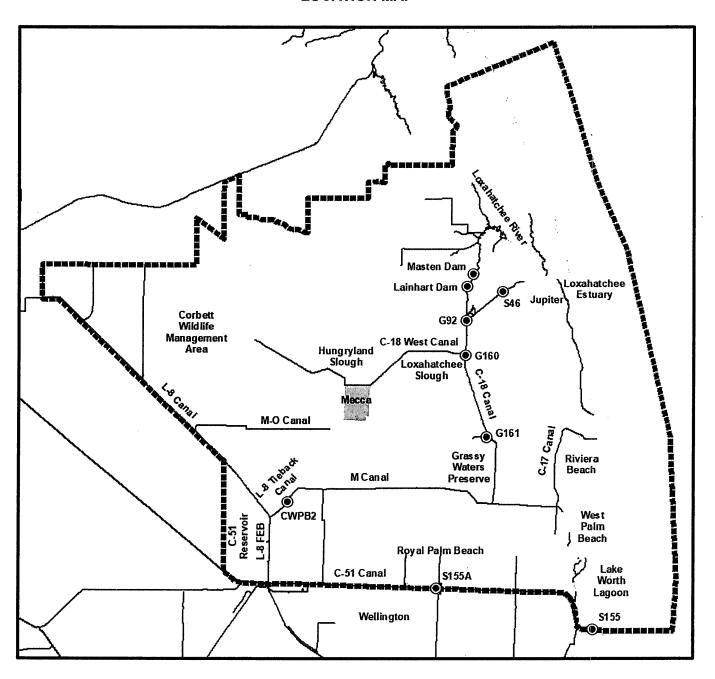
