### I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Consultant Services Authorization (CSA) No. 14 to the Utility Distribution & Collection System Engineering Services Contract (Contract) with Mock, Roos & Associates, Inc., (Consultant) for the Palm Beach National Golf and Country Club Water Main Replacement (Project) for a fixed price of \$103,873.80.

Summary: On June 20, 2017, the Board of County Commissioners approved the Palm Beach County Water Utilities Department (WUD) Contract (R2017-0818) with Consultant. CSA No. 14 provides for professional engineering services relating to design and permitting of the Project. These services include construction plans, technical specifications, permitting, and bid support services for the replacement of approximately 21,680 linear feet of 4-inch and 6-inch asbestos cement watermains, including the affected water services within Palm Beach National Golf and Country Club. This Contract was procured under the requirements of the 2002 Small Business Enterprise (SBE) Ordinance (R2002-0064) prior to the adoption of the new Equal Business Opportunity Ordinance on October 16, 2018. The SBE participation goal established under the 2002 Ordinance was 15% overall participation. The Contract provides for 97% SBE participation. CSA No. 14 includes 100% SBE participation. The cumulative SBE participation is 75.95%. Consultant is a Palm Beach County Company. The Project is included in the WUD FY19 Budget. (WUD Project No.19-048) District 2 (MJ)

Background and Justification: The existing water mains to be replaced under the Project are substandard asbestos cement pipe, undersized and lack fire protection. The Project is needed to restore the service life, efficiency, and effectiveness of the water distribution system within Palm Beach National Golf and Country Club, while reducing the operations and maintenance workload and associated cost.

### SCOPE OF SERVICES

#### Project No. WUD <u>19-048</u>

# Project Title Palm Beach National Golf and Country Club Watermain Replacement

#### INTRODUCTION

The Palm Beach National Golf and Country Club potable water distribution system was constructed in the early 1970s by a private developer and taken over by Palm Beach County Water Utilities Department (WUD) in 1980. The potable water distribution stystem within the community primarily consists of approximately 21,680 linear feet of 4-inch and 6-inch diameter asbestos cement pipe which has been in service for over 40 years. The distribution system is currently connected to only four (4) fire hydrants which serves condominiums that were constructed in the mid-1990s which is located on the south portion of the Palm Beach National Golf and Country Club. The majority of the development does not have adequate fire protection and thus necessitating this project to restore service life, efficiency and effectiveness within the Palm Beach National Golf and Country Club.

This replacement project will be completed in accordance with the following regulations and standards:

- Palm Beach County Water Utilities Department minimum design and construction standards for Potable Water, Reclaimed Water and Wastewater Systems.
- Palm Beach County Right-of-Way (ROW) permitting regulatory agencies
- Lake Worth Drainage District Right-of-Way permitting for aerial crossings
- Palm Beach County Fire Marshal Code which includes but not limited to:
  - Fire hydrants being installed within five hundred (500') feet from the most remote portion of building, measured by vehicular access and building perimeter.
    - The number of fire hydrants being installed shall be in accordance with Annex E of the National Fire Protection Association (NFPA 1) Fire Code.

#### SCOPE OF SERVICES

CONSULTANT shall perform the engineering Scope of Services as described herein and will be responsible for the following tasks:

#### Task 1 – Project Management

CONSULTANT will provide project management for engineering and related services and act as the Project's Engineer of Record for the above-described project including tracking project scheduling, preparing monthly progress reports, providing Quality Assurance/Quality Control (QA/QC) of all communication and project deliverables.

 Contract Administration – The progress of the project will be monitored and resources will be managed to achieve the schedule, budget, and work quality goals of the project. CONSULTANT will keep WUD informed as to the status and progress of the project. Communications with WUD will be conducted under this task. Invoices shall be prepared on a monthly basis.

- 2. QA/QC CONSULTANT will be conducting internal QA/QC review of the deliverables for conformance to Contract and internal program requirements. The results of these reviews will be incorporated into the deliverables prior to submission to WUD for review and comment.
- 3. Monthly Status Report Submit a monthly status report summarizing the progress of the project along with an updated project schedule. This report and schedule will be submitted with each monthly invoice.

#### Task 2 - Preliminary Engineering Services

- 1. CONSULTANT shall meet with WUD staff to review the scope of the project, determine general location of proposed improvements, and obtain WUD's input regarding expectations for the project.
- 2. CONSULTANT shall perform a preliminary field review of the proposed water main and water service replacement locations.
- 3. Utilize a topographic survey of the area in the immediate vicinity of the proposed pipeline routes and provide base maps of the survey data. (Services to be provided by WUD surveyor.) The topographic survey will provide Global Postioning System (GPS) coordinates for all existing water meter locations. The topographic survey will consist of field topography, horizontal and vertical locations for the project (approximately 21,680 linear feet of 60 foot right-of-way). CONSULTANT will coordinate survey file transfer and confirm limits of survey to match project requirements.
- 4. Prepare Base Maps based on the surveyor provided data.
- 5. Determine conflict locations and develop preliminary pipeline alignment plan.
- 6. Submit base drawings to local utilities for mark-up of their existing utilities. Plot utility locations received on the drawing base sheets. Local utilities include, but not limited to, telephone, cable, and gas, as well as water and sewer.
- 7. Coordinate subsurface utility targeting service and subsurface utility locating by test hole, maximum 20 locations. (Services to be provided by subconsultant under our Consultant Service Authorization (CSA #13) (WUD 18-026.)
- 8. Submit preliminary base sheets to WUD for review and comment.
- 9. Develop preliminary construction sequencing plan to facilitate construction of proposed improvements while maintaining water service and vehicle access to existing homes during project construction.
- 10. Meet with WUD staff to review preliminary submittal and respond to questions or comments. Prepare meeting agenda and minutes.

#### Task 3 - Design Phase Services

- 1. Provide design phase engineering services to develop the details of the replacement water main and water services design. This task includes QA/QC activities for the design phase.
- 2. Develop one set of construction drawings consisting of a cover sheet, key sheet, plan and WUD detail sheets.
- 3. Prepare technical specifications and bid items for the project, which is anticipated to be bid as a single project.
- 4. Submit progress drawings at the 60-percent and 90-percent completion for review and comment.
- 5. Meet with WUD after each submittal to review progress drawings, discuss design options, and respond to questions.
- 6. Estimate quantities and prepare an Engineer's Opinion of Probable Construction Cost (EOPCC) at 100% completion.
- 7. Prepare Palm Beach County (PBC) Health Department and PBC Fire Marshal permit application packages including attachments and submit for approval. (WUD will pay application fees.) Prepare and submit responses to Health Department comments, if required.
- 8. Prepare a PBC right-of-way permit application for utility construction in the PBC rightof-way and submit for approval. (WUD will pay application fees.) Prepare and submit responses to PBC right-of-way comments, if required.
- 9. Prepare Lake Worth Drainage District (LWDD) aerial crossing permit application if applicable. (WUD will pay application fees.) CONSULATANT will prepare and submit response to comments, if required.
- 10. Provide final design phase deliverables consisting of four (4) 24 x 36 inch and two (2) 11 x 17 inch construction drawings and bid items in paper copies, signed and sealed electronic PDF files, and AutoCAD and Word files, as applicable. The CONSULTANT shall print and provide all issued permits.
- 11. Provide limited bid support services to assist WUD to respond to bidders' questions.






