I. EXECUTIVE BRIEF

Title: Department of Housing and Economic Sustainability (DHES) Opportunity Zone Overview.

Summary: This item presents an overview of the federal Opportunity Zone program, a community investment tool providing new tax incentives to investors who support housing and economic development initiatives within designated census tracts. DHES efforts include tools that provide property information and additional funding resources that can be leveraged within Opportunity Zones in Palm Beach County. Countywide (DB)

Background and Policy Issues: DHES manages federal, state, and local program funding for housing and economic development. Housing efforts are supported through the Florida Housing Finance Corporation, the State Housing Investment Program (SHIP), HOME, revenues from the County's Workforce Housing Program and impact fee investment earnings. Economic development programs and services offered by DHES include: Federal loan programs, Industrial Development Revenue Bonds; funding for Brownfields assessment and clean-up; Economic Development Incentives; and the development/implementation of resources such as PBC Interactive. All of these programs can be used to attract and enhance investments in designated Opportunity Zones throughout Palm Beach County.
