**I. EXECUTIVE BRIEF**

**Motion and Title:** Staff recommends motion to approve: Work Order 2018051-53 in the amount of \$832,000 to mill and resurface Old Dixie Highway from SW 18<sup>th</sup> Street to Glades Road utilizing Palm Beach County’s (County) annual asphalt milling and resurfacing contract R2018-1533 (Contract) with Ranger Construction Industries, Inc. (Ranger).

**SUMMARY:** Per County PPM CW-F-050, this work order exceeds the \$200,000 threshold for staff approvals of work orders to annual contracts, thus requiring approval from the Board of County Commissioners (BCC). Approval of this work order will allow the contractual services necessary to construct the improvement. Prior to this work order, approximately \$10 million of Ranger’s \$16 million Contract has been spent or encumbered. This annual construction bid was solicited on July 8, 2018, prior to the effective date of the Equal Business Opportunity (EBO) Ordinance and pursuant to the Small Business Enterprise (SBE) Ordinance at the time. The annual contract is scheduled for renewal by October 15, 2019. On October 16, 2018, the BCC approved the Contract with Ranger to provide milling and resurfacing of County roadways for countywide projects. Ranger proposed 15% SBE participation for the Contract and for this work order. Approval of this work order will result in a cumulative SBE participation of 15% for all the work orders issued under the Contract. District 4 (YBH)

**Background and Justification:** The County desires to construct the improvements in accordance with the attached work order. The budget for the improvements includes striping and marking costs of \$110,000, bringing the total fiscal impact to \$942,000.




