I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to:

- A) accept the donation of \$110,000 from the Friends of the Mounts Botanical Garden, Inc. (Friends) for the display of the Big Bugs Exhibition, by David Rogers Big Bugs, Inc.; and
- **B)** accept the donation of \$1,190 for County staff charges for the County Public Art Administrator's role in contract management, siting, and risk management compliance; and
- **C) approve** a budget amendment in the Cooperative Extension Revenue Fund (Fund 1482) to be used for Cooperative Extension's Big Bugs Exhibition in the amount of \$110,000 and \$1,190, for a total of \$111,190 to complete the installation and display of the Big Bugs Exhibition.

Summary: The Friends agree to fund all costs associated with the Big Bugs Exhibition which covers all expenses, equipment, installation and County staff charges. This work will be led by Art in Public Places and is estimated to cost \$111,190. The \$111,190 is what it will cost to bring the Big Bugs Exhibition to The Mounts Botanical Garden of Palm Beach County on January 10, 2020 through May, 10, 2020. <u>District 7 (AH)</u>

Background and Justification: Art exhibits, both traveling and stationary are part of the conceptual Master Plan for The Mounts Botanical Garden of Palm Beach County. The Big Bugs Exhibition will reinforce the Mounts Botanical Garden mission to inspire and educate, and enhance the sensory and spiritual experience of the Garden. Sculpture siting shall be at the discretion of Mounts Botanical Garden staff and the County's Facilities Development & Operations/Strategic Planning/Art in Public Places Administrator.

Friends of Mounts Botanical Garden, Inc. Letter to Donate

Dear Palm Beach County Board of County Commissioners,

This letter is to certify that The Friends of the Mounts Botanical Garden, Inc., a Florida Not For Profit Corporation ("Friends"), will donate \$111,190 to Palm Beach County, a political subdivision of the State of Florida ("County"), conditioned upon the use of this donation for display of the Big Bugs Exhibition, by David Rogers Big Bugs, Inc. Friends shall deliver a check made payable to Palm Beach County Board of County Commissioners in the amount of \$111,190 to the County's Cooperative Extension Department within 10 days of the County's acceptance and execution of this donation letter. Friends acknowledges that the County will not execute any agreement with David Rogers Big Bugs, Inc. for the installation and display of the Big Bugs Exhibition until the donation is received by the County.

Friends agrees to fund all costs associated with this project. The Friend's donation of \$111,190 to the County includes: 1) a \$110,000 fee for the Big Bugs Exhibition which covers all expenses, equipment and installation of the Big Bugs Exhibition and 2) County staff charges of \$1,190 for the County Public Art Administrator's role in contract management, siting, and risk management compliance. While the Big Bugs Exhibition is on display, Friend's also agrees to pay for and keep in full force and effect general liability and property damage insurance as detailed in the Agreement to Host Big Bugs Exhibition.

The Big Bugs Exhibition will reinforce the Mounts Botanical Garden mission to inspire and educate, and enhance the sensory and spiritual experience of the Garden. The installation of the Exhibition will take approximately one week and the Exhibition is scheduled to be on display from January 10 - May 10, 2020. Sculpture siting shall be at the discretion of Mounts Botanical Garden Staff and the County's Facilities Development & Operations/Strategic Planning/Art in Public Places Administrator.

Friends selected David Rogers Big Bugs, Inc. without consultation with or advice from the County. Friends acknowledges that it and the County will be entering into an Agreement with David Rogers Big Bugs, Inc. to host the Big Bugs Exhibition; and Friends agrees that it will be responsible for any and all costs in excess of the \$111,190 that are associated with the Big Bugs Exhibit, including, but not limited to, costs of litigation and any costs or deductibles arising from County taking responsibility for the care, custody and control of the Sculptures while the Sculptures are installed at MOUNTS.
