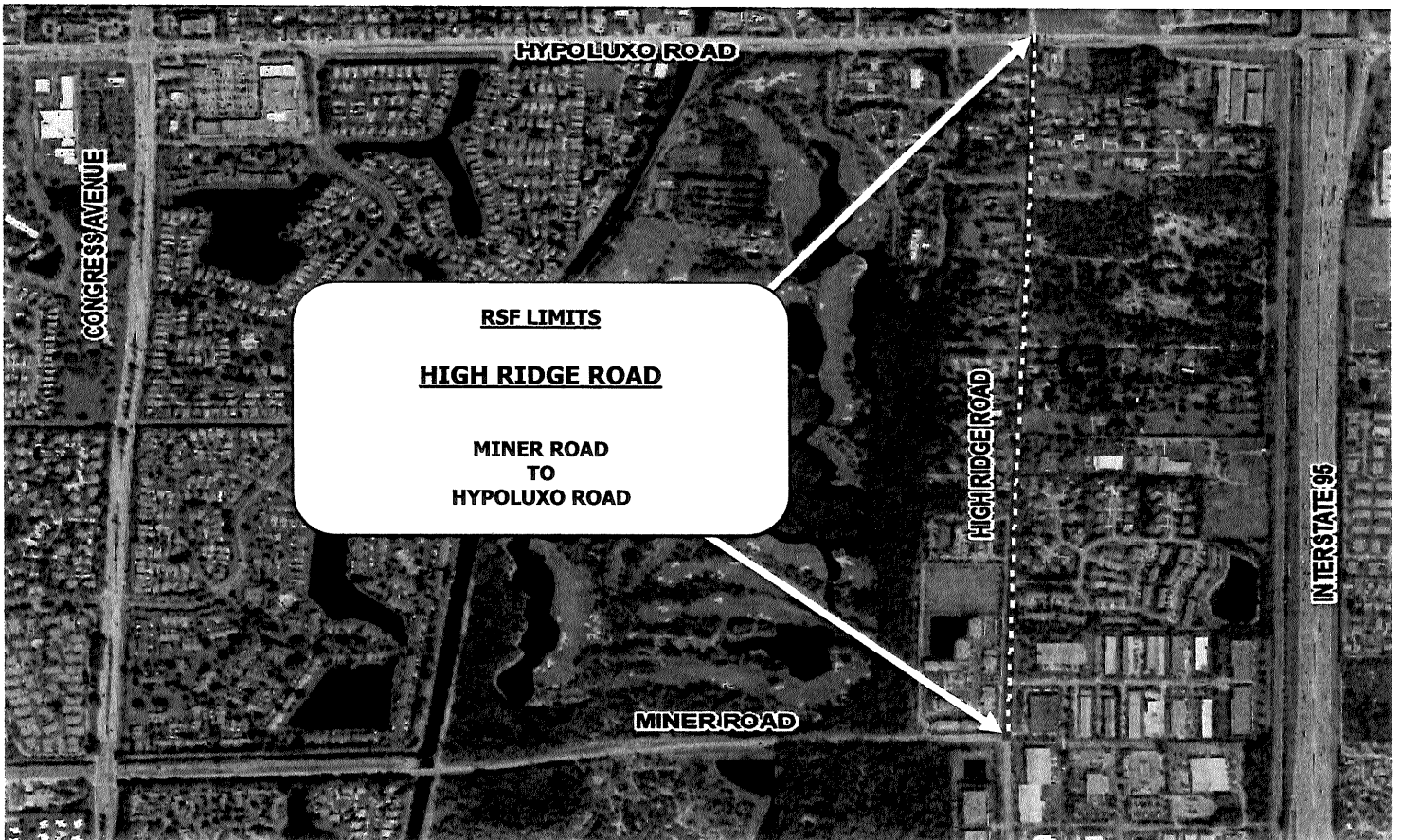
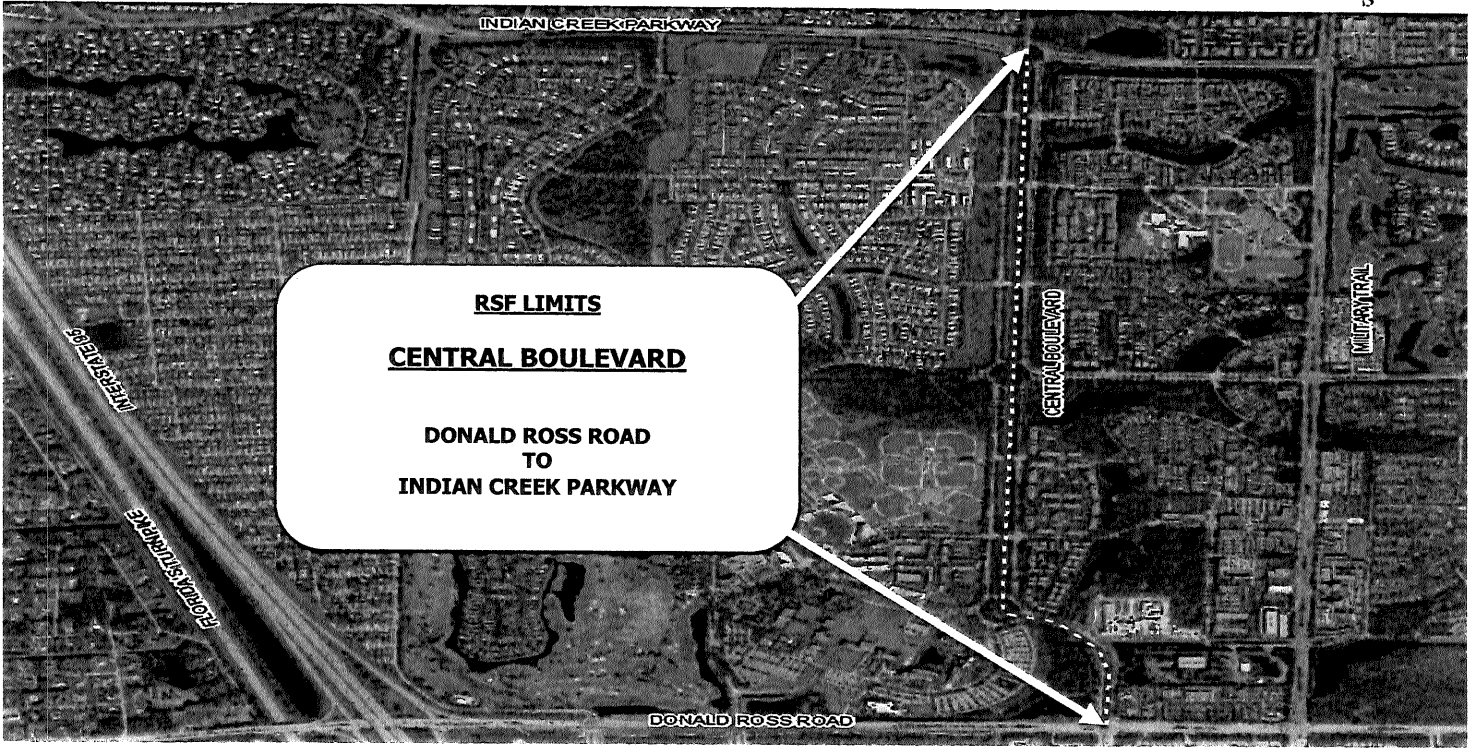

WITNESSETH

WHEREAS, the **COUNTY** and **CONTRACTOR** entered into an Annual Contract ("**CONTRACT**") for milling and resurfacing on a work order basis on October 16, 2018 (R 2018-1533); and

WHEREAS, the first amendment to the **CONTRACT**, executed on October 22, 2019, increased the total amount available from \$16,000,000 to \$31,400,000 and extended the expiration date from October 15, 2019 to October 15, 2020; and

WHEREAS, the **COUNTY** desires the **CONTRACTOR** to mill and resurface High Ridge Road from Miner Road to Hypoluxo Road in Palm Beach County, Florida ("**IMPROVEMENTS**"); and

WHEREAS, the **CONTRACTOR** agrees to construct the **IMPROVEMENTS** in accordance with the terms and conditions of the **CONTRACT** and as directed and accepted by the Engineering Department, Road & Bridge Division; and
