Motion and Title: Staff recommends motion to: A) approve an Impact Fee Affordable Housing Assistance Program (IFAHAP) funding award in the amount of \$3,511 to Palm Beach Habilitation Center Inc. (PBHC) for their Memory Care Cindy Drive project; **B) authorize** the Mayor to execute a Certificate of Award to be released to the recipient pursuant to IFAHAP Guidelines; **C) approve** a Budget Transfer of \$3,168 in Impact Fee Assistance Program – Roads Zone 3 to appropriate funds for PBHC; and **D) approve** a Budget Transfer of \$343 in Impact Fee Assistance Program – Public Building to appropriate funds for PBHC.

Summary: Staff recommends Board of County Commissioners' (BCC) approval for an IFAHAP funding award in the amount of \$3,511 to PBHC for their Memory Care Cindy Drive project (Project). On April 1, 2019, the Department of Housing and Economic Sustainability issued a Notice of Funding Availability (NOFA) making \$1,822,458 in IFAHAP funding available from Palm Beach County's Fiscal Year 2018 funding cycle. On April 15, 2019, PBHC submitted an application in response to the NOFA. Staff recommends that up to \$3,511 be provided as a credit for impact fees associated with the Project. PBHC will be given credits for Roads Zone 3 Impact Fees (\$3,168), and Public Building Impact Fees (\$343) for the construction of the Project. PBHC will pay impact fees above the allocated \$3,511. The Project entails construction of a six (6) bed memory care group home for persons diagnosed with Alzeheimer's, dementia or age-related limitations located at 440 Cindy Drive in Wellington. According to IFAHAP requirements, all six (6) units will be for rent to persons with incomes no greater than 140% of Area Median Income. The assisted units will be restricted to remain affordable for 20 years. These funds are from interest earned by the Impact Fee Fund. District 6 (HJF)

Background and Justification : On November 17, 2009, the BCC authorized the use of impact fee investment earnings from roads, parks, and public buildings for affordable housing projects. On April 10, 2018, the BCC approved the current IFAHAP Guidelines. The IFAHAP NOFA made funds available to for-profit and non-profit developer entities seeking to build affordable rental housing units or for-sale housing units and to individuals seeking to build owner-constructed/occupied housing units for use as their principal place of residence. The 2018 NOFA funds must be encumbered no later than March 12, 2020, and Certificate(s) of Occupancy must be obtained for all assisted units and such units must be occupied by eligible households within four (4) years after the date of funding approval by the BCC. A responsiveness review determined that the PBHC application was responsive thus warranting recommendation for a funding reservation of impact fee credits.


