#### I. EXECUTIVE BRIEF

#### Motion and Title: Staff recommends motion to:

- A) ratify the signature of the Mayor on the 2019 U.S. Department of Justice (USDOJ) Comprehensive Opioid Abuse Site-Based Program Award, for the period October 1, 2019 through September 30, 2022, in the amount of \$1,200,000, to support the development of a comprehensive, locally driven response to the opioid epidemic;
- B) delegate to the County Administrator, or designee, signatory authority to sign subcontracts, any additional amendments or forms, and any other necessary documents related to the 2019 USDOJ Comprehensive Opioid Abuse Site-Based Program Award;
- C) approve one (1) full-time equivalent (FTE) position for a Planner II (Pay Grade 34); and
- **D) approve** a budget amendment and transfer in the amount of \$1,200,000 in the General Fund, Behavioral Health Programs unit, to align the budget to the grant award and transfer the balance from the Community Services administrative unit to the Behaviroal Health Programs unit.

Summary: Palm Beach County has been awarded federal funding under the Department of Justice, Office of Justice Programs, Bureau of Justice Assistance, Comprehensive Opioid Abuse Site-Based Program. The program will utilize the Sequential Intercept Model (SIM) and its goal of minimizing unnecessary involvement of individuals with substance use disorder in the justice system by diverting them from going to jail or by ensuring their swift and safe return to the community with access to Medication Assisted Treatment (MAT) and peer/professional support services. Emphasis will be placed on assisting with the provision of transitional/recovery housing options for targeted individuals with a substance use disorder who are reentering the community following a jail stay. The project will operate through a subaward to the Southeast Florida Behavioral Health Network, Inc. (SEFBHN) in collaboration with the Palm Beach County Sheriff's Office (PBSO) for the duration of the funding period. SEFBHN will be responsible for achieving the grant's goals and objectives. SEFBHN will also work closely, cooperatively and collaboratively with the Senior Program Manager, Office of Behavioral Health and Substance Use Disorder, within the Community Services Department (CSD), who will oversee the project and monitor the grant activities. The Planner II position is needed to execute the planning and implementation phases of the project, oversee the collection of outcome data that will drive the ongoing service array, work collaboratively with the advisory task force and working group members as well as strategic partners, and monitor recovery support and other client services. The new position will be 50% funded from the grant and 50% from previously allocated opioid response funding. The position will be for the length of the grant and will be eliminated if grant funding is discontinued. No additional County funding is required. (Community Services) Countywide (HH)

**Background and Policy Issues:** The CSD successfully led a team to gather and prepare all required information needed to ensure receipt of this grant award. CSD will work closely with subawardees and monitor grant activities to ensure its goals are being met. The grant will provide opportunities to divert individuals from going to jail or by ensuring their swift and safe return to the community with meaningful supports, thereby reducing burdens on the Sheriff's Office, the Courts and the County.

Pursuant to Section 309 of the Administrative Code, your signature is needed on the 2019 USDOJ Comprehensive Opioid Abuse Program Grant Award 2019-AR-BX-K023. On August 20, 2019, the Board of County Commissioners approved the FY 2019 Comprehensive Opioid Abuse Site-based Program Application. The award period is for three (3) years, with a start date of October 1, 2019.

The total funding for Palm Beach County for the three-year period is as follows:

Palm Beach County has been awarded federal funding under the U.S. Department of Justice (USDOJ) Comprehensive Opioid Abuse Program Grant Program to support the development of a comprehensive, locally driven response to the opioid epidemic.

The overall goal of the project is to reduce the number of overdose fatalities in the County and to mitigate the overreliance on the justice system to address the behavioral health needs of affected individuals.

Utilizing Sequential Intercept Modeling (SIM) and its goal of minimizing unnecessary involvement of people with substance use disorders in the justice system, the project prioritizes individuals at the second (arrested), third (jail/courts), fourth (re-entry), and, fifth (community corrections) SIM intercepts given the opportunity to divert these individuals from penetrating through the justice system and to swiftly return them back into the community, with meaningful support, as well as creating access to medication-assisted treatment and peer/professional support. Special emphasis will be placed on assisting with the provision of transitional/recovery housing options for targeted individuals with a substance use disorder in order to support their recovery process and success in diversion referral programming. The project will be managed by the County's Community Services Department, Office of Behavioral Health and Substance Use Disorders, in collaboration with the Southeast Florida Behavioral Health Network (SEFBHN) and the Palm Beach County Sheriff's Office for the duration of the funding period. The project also will engage Florida Atlantic University (FAU) as a research partner.

#### 15. SUMMARY DESCRIPTION OF PROJECT (See instruction on reverse)

The Comprehensive Opioid Abuse Site-based Program (COAP) was developed as part of the Comprehensive Addiction and Recovery Act (CARA) legislation. COAP's purpose is to provide financial and technical assistance to states, units of local government, and Indian tribal governments to plan, develop, and implement comprehensive efforts to identify, respond to, treat, and support those impacted by the opioid epidemic. The Harold Rogers Prescription Drug Monitoring Program (PDMP) has been incorporated into the FY 2019 COAP solicitation. The purpose of the Harold Rogers PDMP is to improve collaboration and strategic decision making among regulatory and law enforcement agencies and public health entities to address prescription drug and opioid abuse, save lives, and reduce crime.

14. THIRD YEAR'S BUDGET AMOUNT

COAP aims to reduce opioid abuse and the number of overdose fatalities, as well as to mitigate the impacts on crime victims by supporting comprehensive, collaborative initiatives. The program also supports the implementation, enhancement, and proactive use of PDMPs to support clinical decision making and prevent

the abuse and diversion of controlled substances. Grantees are prohibited from using federal funds to support activities that violate the Controlled Substances Act. The objective of Category 1 is to encourage and support the development of comprehensive, locally driven responses to the opioid epidemic that expand access to supervision, treatment, and recovery support services across the criminal justice system; support law enforcement and other first responder diversion programs for non-violent drug offenders; promote education and prevention activities; and address the needs of children impacted by the opioid epidemic. All projects are expected to involve multiple agencies and partners. The Palm Beach County Comprehensive Opioid Abuse Program will reduce the number of overdose fatalities, as well as mitigate the impacts on crime victims, by supporting a comprehensive, collaborative county-wide initiative to the opioid epidemic, with a special emphasis on assisting with the provision of transitional/recovery housing options for targeted individuals with a substance use disorder in order to support their recovery process and success in diversion referral programming. Palm Beach County will offer medication-assisted treatment (MAT) in jail along with additional treatment services, including peer support. Awards under the Comprehensive Opioid Abuse Program (COAP) will be used improve collaboration and strategic decision-making of regulatory and law enforcement agencies and public health officials to address prescription drug and opioid misuse, save lives, and reduce crime.

None of the following activities will be conducted whether under the Office of Justice Programs federal action or a related third party action:

1) New construction.

- 2) Renovation or remodeling of a property located in an environmentally or historically sensitive area, including property (a) listed on or eligible for listing on the National Register of Historic Places, or (b) located within a 100year flood plain, a wetland, or habitat for an endangered species.
- (3) A renovation that will change the basic prior use of a facility or significantly change its size.
- (4) Research and technology whose anticipated and future application could be expected to have an effect on the environment.
- (5) Implementation of a program involving the use of chemicals.

Additionally, the proposed action is neither a phase nor a segment of a project which when reviewed in its entirety would not meet the criteria for a categorical exclusion. Consequently, the subject federal action meets the Office of Justice Programs' criteria for a categorical exclusion as contained in paragraph 4(b) of Appendix D to Part 61 of Title 28 of the Code of Federal Regulations.
