I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: 3 precinct boundary changes, submitted by Wendy Sartory Link, Supervisor of Elections, as required by section 101.001(1), Florida Statutes.

Summary: 3 Precinct boundary changes are recommended by Wendy Sartory Link, Supervisor of Elections (SOE), due to municipal annexations in Delray Beach and Palm Springs. Districts 3 and 5 (AH)

Background and Justification: Florida Statute, section 101.001(1) requires that precinct boundary changes must be approved by a majority of the Board of County Commissioners, upon recommendation and approval of the SOE. 


