I. EXECUTIVE BRIEF

1. Motion and Title:

Staff recommends motion to Receive and File: Annual financial reports, excess fees and unexpended budget for Fiscal Year 2018-2019, for the Clerk & Comptroller, Tax Collector, and Property Appraiser.

B. Summary:

The financial reports of these Constitutional Officers were submitted to the Office of the Clerk & Comptroller on or before October 31, 2019, in accordance with Section 218.36, Florida Statutes. The amounts shown for the Tax Collector and the Property Appraiser represent the total payment to the County. A portion of these revenues are budgeted in the Library, Fire-Rescue, and various other special revenue funds.

The amounts shown as additional/decrease in excess fees will be included in the adjustment for additional balances brought forward, which will be brought to the Board of County Commissioners in March 2020.

Dear Mayor Bernard:

In four terms as Palm Beach County's independently elected Constitutional Clerk & Comptroller, one of my top priorities has been effective and efficient government. I proudly serve as the taxpayer's advocate for transparency and accountability in government finance. As a fiduciary, my duty is to ensure money is spent legally, within your budget, and with the taxpayers' interests at the forefront.

This commitment to fiscal responsibility and accountability extends to my office as well, and I'm therefore proud to enclose a check to Palm Beach County for \$653,286.30. This amount is from my Comptroller division for unspent revenue. I've also enclosed, pursuant to Florida Statute 218.36, the Clerk & Comptroller's Fiscal Year 2019 Constitutional Officer's Financial Report.

My office's guiding principle of finding new ways to provide outstanding service, while utilizing technology to maximize efficiency, has led to our saving operational money. In fact, my Comptroller division has reduced its operational costs by 15.3 percent since 2007, and returned to Palm Beach County a combined total of \$47,717,105.44 since 2005. Significant initiatives by my team for FY 2019 include:

- Producing \$60.4 million in investment income in the County's investment portfolio – an increase of \$26 million, or 78%, from FY 2018. This is accomplished through my professional investment team's daily active portfolio management.
- Offsetting \$2.2 million in banking fees, through proactive management of the County's banking contract with Wells Fargo.
- Generating \$135,529.52 in cash rebates for the County, by effectively leveraging technology to streamline vendor payments and reduce the need for processing paper checks. This program has generated a total of \$1,585,899.30 in rebates since 2014.

In FY 2019, our commitment to excellent financial stewardship and our fiscal strategy has resulted in a total of \$63,388,815.82 for Palm Beach County and its taxpayers.

I am proud of the work we all have done on behalf of Palm Beach County and its taxpayers. I look forward to continuing our positive and productive relationship in 2020.




