I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: Second Amendment to Signatory Airline Agreement with JetBlue Airways Corporation (JetBlue), adding additional space to JetBlue's leasehold at the Palm Beach International Airport (PBI) terminal building, effective March 1, 2020, for payment of additional rent in the initial amount of \$95,044.12 per year.

SUMMARY: The Second Amendment adds 1,724 square feet of associated space in the operations area to JetBlue's leasehold, effective March 1, 2020. Delegation of authority to agree to modifications of an airline's leasehold premises, as provided in this Second Amendment, was approved by the Board in R-2019-1155. <u>Countywide</u> (AH)

SECOND AMENDMENT TO SIGNATORY AIRLINE AGREEMENT BETWEEN PALM BEACH COUNTY AND JETBLUE AIRWAYS CORPORATION

THIS SECOND AMENDMENT TO SIGNATORY AIRLINE AGREEMENT (this

"Second Amendment") is made and entered into this <u>February 21</u>, 20<u>20</u> (the "Effective Date"), by and between Palm Beach County, a political subdivision of the State of Florida ("County"), and JetBlue Airways Corporation, a Delaware corporation, having its office and principal place of business at 27-01 Queens Plaza North, Long Island City, New York 11101 ("Airline").

WITNESSETH:

WHEREAS, County, by and through its Department of Airports (the "Department"), owns and operates the Palm Beach International Airport, located in Palm Beach County, Florida; and

WHEREAS, pursuant to the Signatory Airline Agreement between County and Airline dated September 30, 2019, as amended (the "Agreement"), Airline leases various terminal facilities and equipment at the Airport in connection with its operations as a commercial air carrier; and

WHEREAS, the Director of the Department has been delegated the authority to execute certain amendments to the Agreement pursuant to County Resolution No. 2019-1155; and

WHEREAS, the parties desire to amend the Agreement as provided for herein.

NOW, THEREFORE, in consideration of the premises and of the mutual covenants herein contained, and for other good and valuable consideration, the receipt of which the parties hereby expressly acknowledge, the parties hereto covenant and agree to the following terms and conditions:

- 1. The foregoing recitals are true and correct and are hereby incorporated herein by reference and made a part hereof. Terms not defined herein shall have the meaning ascribed to them in the Agreement.
- 2. Effective March 1, 2020, Exhibit "B" (Preferential Use Premises (Terminal Areas)) to the Agreement shall be deleted in its entirety and replaced with Exhibit "B" (Preferential Use Premises (Terminal Areas)) attached to this Second Amendment, and incorporated herein.
- 3. Except as specifically modified herein, all of the terms and conditions of the Agreement shall remain unmodified and in full force and effect and are hereby ratified and confirmed by the parties hereto.
- 4. This Second Amendment shall become effective when signed by both parties hereto and approved by Palm Beach County.

First Level Plan – Palm Beach International Airport Main Terminal






First Level Plan – Palm Beach International Airport Concourse "C"




Third Level Plan – Palm Beach International Airport Main Terminal


