I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to adopt: a Resolution supporting the Westgate Belvedere Homes Community Redevelopment Agency's (Westgate CRA) application for the Palm Beach Transportation Planning Agency's (TPA) Transportation Alternatives Program (TAP) grant funding to install sidewalks, pedestrian crosswalks and streetlights on Cherry Road from Military Trail to Quail Drive (Project) in the amount of \$1,456,064.29.

SUMMARY: Approval of this resolution will comply with a TPA requirement that, for federally funded projects, a resolution is necessary to establish the local agency's commitment to construct, operate and maintain the project. Since Palm Beach County (County) is a certified agency for the Florida Department of Transportation's Local Agency Program and the owner of the Cherry Road right-of-way, the Westgate CRA has requested that the County design and construct the project. If the application is approved, the Westgate CRA will execute an agreement with the County memorializing the responsibilities and requirements between the Westgate CRA and the County to implement the project from design through construction. The CRA will be responsible for operation and maintenance after completion of construction. District 7 (YBH)

Background and Justification: The TPA requested grant applications from local agencies for the grant funding available from TAP. In response, the Westgate CRA submitted an application for funding to install sidewalks, pedestrian crosswalks and streetlights on Cherry Road from Military Trail to Quail Drive in the Belvedere Homes neighborhood. The amount requested from the TPA is \$1,456,064.29. The TPA has determined that a resolution by the Board of County Commissioners is the proper instrument to comply with the federal requirement for commitment to the project. The Westgate CRA has provided written assurances to the Engineering Department, to pay all costs for operation and maintenance of the project, plus all costs that may be over and above the amount of funding approved by the TAP grant. This Resolution assures that the County supports the project and the Westgate CRA's application for funding.



RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PALM BEACH COUNTY, FLORIDA, SUPPORTING THE WESTGATE BELVEDERE HOMES COMMUNITY REDEVELOPMENT AGENCY'S APPLICATION FOR THE PALM BEACH TRANSPORTATION PLANNING AGENCY'S TRANSPORTATION ALTERNATIVES PROGRAM GRANT FUNDING TO INSTALL SIDEWALKS, PEDESTRIAN CROSSWALKS AND STREETLIGHTS ON CHERRY ROAD BETWEEN MILITARY TRAIL AND QUAIL DRIVE.

WHEREAS, the Westgate Belvedere Homes Community Redevelopment Agency (Westgate CRA) has identified a need to develop a complete streets project to install sidewalks, pedestrian crosswalks and streetlights on Cherry Road between Military Trail and Quail Drive in the Belvedere Homes neighborhood (Project); and

WHEREAS, the Board of the Westgate CRA has unanimously authorized the budget to fully fund and maintain the Project; and

WHEREAS, the Project qualifies for the Palm Beach Transportation Planning Agency's (TPA) Transportation Alternatives Program (TAP) grant, a cost-reimbursement program where projects are submitted to the TPA for ranking and prioritization for funding; and

WHEREAS, the Westgate CRA has requested that Palm Beach County (County), a certified agency for the Florida Department of Transportation's Local Agency Program and owner of the Cherry Road right-of-way, support the TAP grant application on its behalf; and

WHEREAS, the Westgate CRA will execute an agreement with the County for the implementation of the Project from its design through construction if the TAP grant application is approved by the TPA; and

WHEREAS, the Westgate CRA will be responsible for operation and maintenance of the Project after completion of construction; and

WHEREAS, the Westgate CRA will be required to obtain a right-of-way permit from the County to undertake operation and maintenance activities within the Cherry Road right-of-way; and

WHEREAS, as documentation of commitment to the project, the TPA has requested that the County adopt a resolution in support of the project and TAP grant application; and

WHEREAS, the Board of County Commissioners (BCC) has determined execution of this Resolution to be in the best interest of the citizens and residents of the County.

NOW, THEREFORE be it resolved by the Board of County Commissioners of Palm Beach County, Florida, that the Mayor is hereby authorized to execute the Resolution.

- 1. The recitations set forth herein above are true, accurate, and correct and are incorporated herein.
- 2. The BCC does hereby support the Project, contingent upon the execution of the agreement between the Westgate CRA and the County.
- 3. This Resolution will take effect upon its adoption.
