Project Description

Emergency operating expenses for evacuations, temporary emergency service, disaster preparation, and repairs due to Hurricane Irma, Palm Beach County went into Level 2 activation status at 7:00 AM on Thursday, September 7, 2017 through Wednesday September 13.

Flood Insurance attached, for building expenses Insurance claims not made due to deductible being higher than expense, other expenses are not insurable. No FEMA funds have been received. The expenses for repairs were incurred at Palm Tran's South County Facility, 100 N. Congress Ave. Delray Beach, FL 33445.

The facility is located in area identified by FEMA as of Minimal Flood Hazard. Documentation on the property actually being above the established 100 year flood elevation has been uploaded to TrAMS (Palm Tran South County Facility Located in Area of Minimal Flood Hazard).

The property was built to minimize the effects of the hazard with proper drainage. The property has been in service since 1996 with no reports to date of any flooding issues. Repairs reported in this application were not caused by water damage, or related to flooding.

Additional costs were incurred after the emergency period, but Hurricane Related Service. The Federal Disaster Supplemental Nutrition Assistance Program (DSNAP) operated out of three (3) different parks in order to allow those affected by the Hurricane to apply for food stamps. Palm Tran provided service to those parks including Paratransit Services. Operations confirmed there were five (5) days in which Palm Tran Provided services exclusively for the DSNAP program.

These services took place from: Tuesday October 17 to Saturday October 21, 2017, after the emergency period but these were Hurricane Relief activities. The bus services were provided by Palm Tran's Fixed Route operators using Palm Tran equipment, and paratransit services were provided by the existing Paratransit Contractors.

Fixed Route and Paratransit Services provided by Palm Tran after a declared emergency, facilitated Palm Beach County residents hurricane preparation, evacuation, safety return and mitigation activities after the Hurricane. Palm Tran provided 2,371 Fixed Route trips and 2,342 Paratransit trips. After the emergency, Palm Tran assisted with the evacuation of animals shelters, and the provision of temporary services to allow County residents to apply for the Disaster Supplemental Nutrition Assistance Program (D-SNAP) which gives food assistance to low-income households with food loss or damage caused by a natural disaster.

Location Description

Palm Tran, Inc. provides public transit service in Palm Beach County, Florida. Palm Tran has several "facilities" located throughout Palm Beach County that include administrative services; bus, relief vehicle and employee parking; and maintenance operations. Maintenance Facilities are located in the cities of West Palm Beach, Delray Beach (100 N Congress Ave, Delray Beach, FL 33445) and Belle Glade. Palm Tran serves 3,200 bus stops with 34 Fixed Routes that cover Palm Beach County as far north as the Town of Jupiter and as far south as the City of Boca Raton. One route travels to the rural western boundary of the County where it connects with a circulator route that serves the communities of Belle Glade, Pahokee Canal Point and South Bay. Palm Beach County is one of the three counties in South Florida that make up the Miami metropolitan area (Miami-UZA). There are 39 incorporated municipalities within Palm Beach County including Boca Raton, Delray Beach and the largest city being West Palm Beach. The county has a total area of 2,383 square miles, Palm Beach County borders Martin County to the north, the Atlantic Ocean to the east, Broward County to the south, Hendry County to the west, and extends into Lake Okeechobee in the northwest.
