I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve:

- A) an Annual Traffic Signal Services contract with Propel Engineering, Inc. (PEI); and
- B) an Annual Traffic Signal Services contract with Simmons & White, Inc. (S&W).

SUMMARY: Approval of these contracts will provide the necessary professional services for traffic signals on a task order basis, for Palm Beach County (County) projects, as required for all user departments. The contract periods are for thirty-six months from the date of approval by the Board of County Commissioners' (BCC). On May 1, 2019, the Goal Setting Committee set Affirmative Procurement Initiatives of Small Business Enterprise (SBE) Evaluation Preference Option 2, with a 20% SBE minimum mandatory participation goal for these contracts. PEI committed to 77% SBE participation and S&W committed to 84% SBE participation. Both are County based certified SBE companies. Countywide (YBH)

Background and Justification: On January 22, 2020, the Consultant's Competitive Negotiations Act Selection Committee selected PEI and S&W and, in accordance with PPM No. CW-O-048, the BCC was notified of the selection on January 24, 2020. The County is now contracting with PEI and S&W to provide the necessary professional services.

After reviewing the attached contracts and finding them in proper order, the Engineering Department recommends BCC approval. Approval of these contracts will ensure the continued process of professional services required by the County.
