





THIRD AMENDMENT TO AGREEMENT FOR EXPERT PSYCHOLOGICAL OR PROFESSIONAL SERVICES IN ADULT AND/OR JUVENILE CRIMINAL MATTERS

THIS AMENDMENT TO THE AGREEMENT, entered into between the Fifteenth Judicial Circuit Court, in and for Palm Beach County, Florida, hereinafter referred to as the “Court” and Palm Beach County Board of County Commissioners, hereinafter referred to as the “County”, shall begin on June 30, 2020, and end on June 30, 2021, for the provision of expert psychological or professional services in adult and/or juvenile criminal matters.

WHEREAS, it has been determined by the Court that it is in the State’s best interest to extend this Agreement until June 30, 2021; and

NOW, THEREFORE, in consideration of the mutual covenants, promises and representations herein contained, the parties agree as follows:

1. This Agreement is amended to extend the completion date of the Agreement from June 30, 2020, to June 30, 2021.

3. All provisions of the Agreement not in conflict with this Amendment are still in effect. This Amendment is subject to the same terms, conditions, and price set forth in the Agreement. Services are to be performed as specified in the Agreement.







THIRD AMENDMENT TO AGREEMENT FOR EXPERT PSYCHOLOGICAL OR PROFESSIONAL SERVICES IN GUARDIANSHIP/EXAMINING COMMITTEE MATTERS

THIS AMENDMENT TO THE AGREEMENT, entered into between the Fifteenth Judicial Circuit Court, in and for Palm Beach County, Florida, hereinafter referred to as the “Court” and Palm Beach County Board of County Commissioners, hereinafter referred to as the “County”, shall begin on June 30, 2020, and end on June 30, 2021, for the provision of expert psychological or professional services in Guardianship/Examining Committee matters.
