Summary: The attached documents have been executed on behalf of the Board of County Commissioners (BCC) by the County Administrator or Designee in accordance with Resolution R2009-0725, and are now being submitted to the BCC to receive and file. ARK 305, LLC was formed to own and operate a Papa John's pizza franchise at 607 South Main Street in Belle Glade. The \$174,444.40 HUD Section 108 loan will be used for working capital and to purchase machinery and equipment necessary to operate the business. The \$181,666.60 USDA IRP loan will also be used for working capital as well as to make tenant improvements to the leased space. Papa John's, an American pizza franchise, is the fourth largest pizza delivery restaurant chain in the United States. The ARK 305, LLC franchise will be the first Papa John's location in Belle Glade. The project is located in a census tract that has a poverty rate of 31%. The project will create at least six (6) full time equivalent job over five (5) years. In accordance with County PPM CW-O-051, all delegated contracts, agreements and grants must be submitted by initiating Department as a receive and file agenda item. These are Federal funds which require no local match. District 6 (DB)

Background and Justification: The Palm Beach County Department of Housing & Economic Sustainability administers the HUD Section 108 Loan program and the USDA IRP to create a source of loan funding for use by businesses and investors to implement business ventures that will create new jobs and help revitalize communities. Funding for the programs are respectively received from HUD and USDA.
