#### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to approve:** Partial Release of Utility Easement for that easement recorded in the Official Records of Palm Beach County, ORB 28047 Page 762.

**Summary:** Palm Beach County Water Utilities Department (PBCWUD) is seeking the release of the County's interest in the utility easement recorded in the Official Records of Palm Beach County as noted above. The Property Owner is requesting release of the portion of the easement that is no longer associated with any public potable water and wastewater facilities. As a result of site development for Sinai Residences, this portion of the existing utility easement is no longer required. PBCWUD has determined that the release of the easement will not affect existing or new public potable water and wastewater facilities and therefore recommends approval of the release. <u>District 5</u> (MJ)

**Background and Justification:** The utility easement listed above was granted/reserved to the County for public potable water and wastewater facilities associated with property identified by PCN 00-42-47-19-35-002-0050 on December 2, 2015.


