I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to approve: Work Authorization (WA) No. 2 to the Continuing Contract for Wastewater Gravity Lines and Manhole Rehabilitation (Contract) with Hinterland Group Inc., (Hinterland) for the Gravity Main and Manhole Rehabilitation (Project) in the amount of \$1,270,266.05.

Summary: On February 5, 2019, the Board of County Commissioners approved the Palm Beach County Water Utilities Department (PBCWUD) Contract (R2019-0216) with Hinterland. WA No.2 provides for the rehabilitation of approximately 32,000 linear feet of existing wastewater gravity pipelines located within West Palm Beach. The required work will include cleaning of the gravity sewer pipelines and manholes, video inspection, and rehabilitation of the pipelines and manholes where necessary. This Contract was procured under the requirements of the 2002 Small Business Enterprise (SBE) Ordinance (R2002-0064) prior to the adoption of the new Equal Business Opportunity Ordinance on October 16, 2018. The SBE participation goal established under the 2002 Ordinance was 15% overall participation. The Contract provides for 91.845% SBE participation. WA No. 2 includes 100% SBE participation. The cumulative SBE participation including WA No. 2 is 100%. Hinterland is a Palm Beach County company. The Project is included in the PBCWUD FY21 Budget (PBCWUD Project 20-048) Districts 2 and 3 (MJ)

Background and Justification: Completion of the work provided for in WA No. 2 will restore the service life of the wastewater system assets, reduce groundwater infiltration to the sewer system, restore system capacity and improve the long-term operability of the wastewater collection system. The Project will also help to reduce the operations and maintenance workload and associated costs.
