#### I. EXECUTIVE BRIEF

**Motion and Title: Staff recommends motion to: (A) Accept** a Bureau of Justice Assistance Bulletproof Vest Partnership Grant in the amount of \$158,469.80 for the period of October 1, 2019, through August 31, 2020 for the purchase of Bulletproof Vests; and (B) Approve a Budget Amendment of \$158,470 in the Sheriff's Grants Fund.

**Summary:** The Bureau of Justice Assistance (BJA) has made available funds for the purchase of Bulletproof Vests for law enforcement personnel. The Palm Beach County Sheriff's Office was awarded the amount of \$158,469.80 for the purchase of National Institute of Justice approved vests. The required match in the amount of \$158,469.80 is provided by the Palm Beach County Sheriff's Office and is included in the Sheriff's approved FY 2020 Budget. Countywide (LDC)

Background and Justification: On June 16, 1998, the Bulletproof Vest Partnership Grant Act of 1998 was signed as law (Public Law 105-181). The purpose of the Act is to save the lives of law enforcement officers by helping states and units of local government and tribal governments equip their law enforcement officers with armor vests. The program requires that each applicant be responsible for providing at least 50% of the cost of each qualifying vest purchased. The Catalog of Federal Domestic Assistance (CFDA) number is 16.607. PBSO is a direct recipient of these funds.
