I. EXECUTIVE BRIEF

Motion and Title: Staff recommends motion to receive and file: a First Amendment ("Amendment") to Infrastructure Surtax Project Funding Agreement for the administration and funding of FY 2020 vehicle replacement dated October 20, 2020, with Ric L. Bradshaw, Sheriff of Palm Beach County (Sheriff), which Amendment extends the term from October 21, 2020 to October 20, 2021.

Summary: In accordance with County PPM CW-O-051, all delegated contracts, agreements and grants must be submitted by the initiating Department as a receive and file agenda item. The attached Amendment has been fully executed on behalf of the Board of County Commissioners (Board) by the Director of Facilities Development & Operations. Background & Justification: The delegation of authority which provided authority for the Director of Facilities Development & Operations to execute standard infrastructure surtax project funding agreements with the Sheriff, was designed to expedite and streamline the process by which the County funds and the Sheriff manages the acquisition and installation of surtax eligible equipment.
