### **I. EXECUTIVE BRIEF**

Motion and Title: Staff recommends motion to adopt: fifteen resolutions to initiate eminent domain proceedings by declaring the acquisition of properties designated as parcels 106, 110, 111, and 113 as right-of-way easements and parcels 306, 309, 310, 311, 313, 314, 317, 321, 322, 323, 334, 336, 337, 338, and 340 as temporary construction easements necessary for the construction of roadway improvements on Seminole Pratt Whitney Road from 86<sup>th</sup> Road North to Northlake Boulevard and on Northlake Boulevard from Seminole Pratt Whitney Road to 1,300 feet east (Project).

**SUMMARY:** Adoption of these resolutions will initiate eminent domain proceedings pursuant to Chapters 73, 74, 127, and Section 337.27(1), Florida Statutes as amended, against 19 parcels having a total appraised value of \$347,631. To date, the property owners have not accepted the offers to purchase made by Palm Beach County (County) and attempts to negotiate the purchases have been unsuccessful. The parcels are necessary for the reconstruction of Seminole Pratt Whitney Road and Northlake Boulevard from two lane undivided roadways to four lane divided roadways. The Project also includes the installation of drainage, traffic signals, and sidewalks. Eminent domain proceedings are necessary to acquire the parcels at this time in order to expedite construction of the Project. This Project is included in the Five Year Road Program. District 6 (DO)

**Background and Justification:** The acquisition of parcels 106, 110, 111, 113, 306, 309, 310, 311, 313, 314, 317, 321, 322, 323, 334, 336, 337, 338, and 340 is for a public purpose and necessity, which is deemed to be in the best interest of the County. The Engineering Department recommends the Board of County Commissioners' approval.
