AMENDMENT 1

AGREEMENT FOR PROVISION OF FINANCIAL ASSISTANCE

THIS AMENDMENT TO THE AGREEMENT FOR PROVISION OF FINANCIAL ASSISTANCE (R-2020-
1549) made and entered into in Palm Beach County on this day of,
20, by and between Palm Beach County, a Political Subdivision of the State of Florida, by
and through its Board of Commissioners, hereinafter referred to as the COUNTY, and PALM
BEACH HABILITATION CENTER INC., hereinafter referred to as the AGENCY, a nonprofit
corporation authorized to do business in the State of Florida, whose Federal Tax I.D. is 59-
<u>6213381</u> .

In consideration of mutual promises contained herein, the COUNTY and the AGENCY agree as follows:

WITNESSETH:

WHEREAS, Palm Beach Habilitation Center, Inc. (PB Hab. Center) and the COUNTY entered into a two-year Agreement on October 20, 2020 (R-2020-1549) (the Agreement) to provide certain services under the Economic Stability Priority Area in an annual amount of \$355,829.00; and

WHEREAS, the need exists to amend the Agreement with PB Hab. Center to update the Agreement amounts for each program by updating and replacing **Exhibit B - Units of Service Rates and Definitions with Exhibit B1 - Units of Service Rates and Definitions**.

NOW, THEREFORE, the COUNTY and the AGENCY mutually agree that the Agreement entered into on October 20, 2020 is hereby amended as follows:

- I. The Whereas clauses above are true and correct and are expressly incorporated herein by reference and made part of the parties' Agreement.
- II. A new Exhibit B1 Units of Service Rates and Definitions, attached hereto, shall replace Exhibit B Units of Service Rates and Definitions in its entirety.
- III. All other provisions of the Agreement, not modified in this First Amendment remain in full force and effect.

UNITS OF SERVICE RATE AND DEFINITION FY 2021 FINANCIAL ASSISTANCE AGREEMENT

AGENCY: Palm Beach County Habilitation Center

Computer Training Program: A unit of service in the Computer Training Program is defined as one day of a minimum of 1.5 hours of instruction in computer training. Participants are provided individualized instruction on employment related software, basic operating and computer skills, accessing the internet, social media, receiving and sending e-mails, improving their reading, math and reasoning skills. Adaptive equipment and software including Dragon Naturally Speaking voice activated software, are available for students who need alternative methods of accessing and manipulating the computer.	\$26.25	\$73,389.00	\$73,389.00
Seniors in Transition and Retirement Services: A unit of service is defined as one day of a minimum of 3 hours of programming per person. Programming can include: opportunities to access proper exercise, nutrition, and community integration experiences. Individual and small group activities focus on providing stimulating activities and physical exercise. Proper nutrition and education concerning the dietary changes are provided through games, instructional materials, and individual and group meetings. Community integration opportunities are provided four to five times per week and include the use of Palm Beach County Parks and Recreation facilities, local bowling facilities, Very Special Arts program, libraries, museums and other community facilities.	\$46.97	\$215,327.00	\$215,327.00

The AGENCY is allowed to expend up to \$4,000 for initial certification or \$1,500 for the annual renewal fee every year of the Agreement. This option exercised by the AGENCY will be taken from the approved budget thus reducing the number of units to be provided. Certification is a requirement of contracting with the COUNTY as referenced in **Article 17** of this Agreement.
